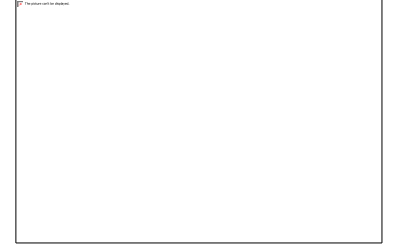
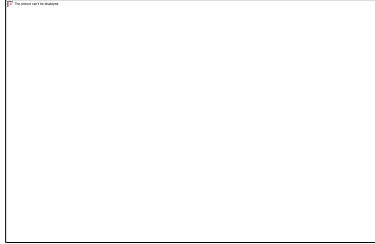

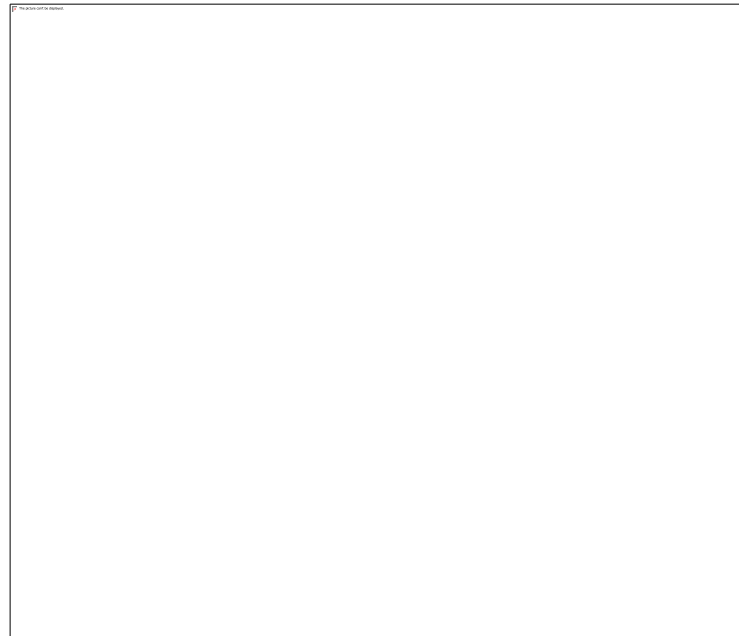
Background

- The revised performance measurement system for the Title V Block Grant emphasized having data available to the States and Jurisdictions for their selection of National Performance Measures
- The jurisdictions have had less access to data to guide their Title V programs
- The Title V MCH Block Grant Jurisdictional MCH Survey is designed to create a mechanism for jurisdictions to begin collecting, reporting and monitoring key MCH indicators over time
- This data collection will enable the jurisdictions to meet Federal performance reporting requirements and to demonstrate the impact of Title V funding relative to MCH outcomes for the U.S. jurisdictions in reporting on their unique MCH priority needs.



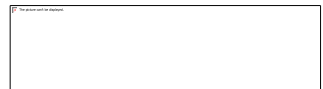
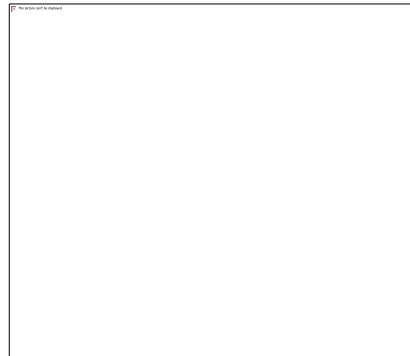
Goals of the Program

- Conduct a survey on child health (similar to the National Survey of Children's Health (NSCH)) and maternal health (e.g. routine well care, mental health , substance use, chronic disease and Zika) in each of the jurisdictions over a four year period.



Goal of the Program

- The survey is intended to enable the eight jurisdictions to collect and report data across all five population domains (i.e., Maternal/Women's Health; Perinatal/Infant Health; Child Health; Adolescent Health; and Children with Special Health Care Needs) on which states/jurisdictions report in the MCH Block Grant Application/Annual Report.
- The goal is also to develop a culturally sensitive survey that will capture data of interest and relevance to the jurisdictions.



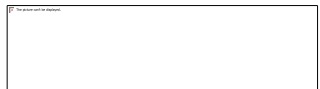
Topics Covered on the Survey

- Children with Special Health Care Needs status
- Overall health status and specific health conditions
- Substance Abuse Disorder
- Injury prevention
- Safe sleep, breastfeeding
- Health care utilization and experiences
- Health insurance
- Health care costs and burden on the family



Topics Covered on the Core Survey Questionnaire

- Child's learning
- Parent-child interactions
- Household smoking and betel-nut chewing
- Parental health
- Zika virus
- Household sociodemographic characteristics

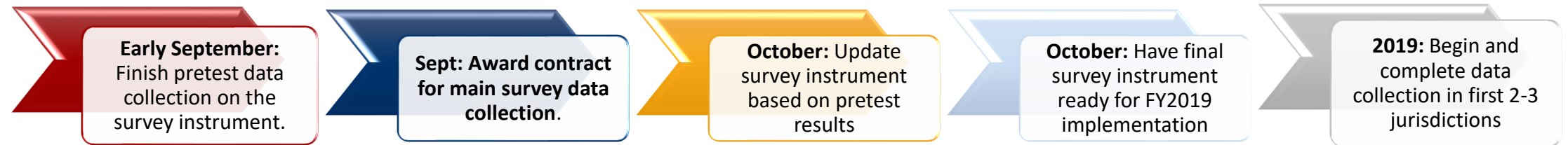


Jurisdiction-specific Questionnaires
