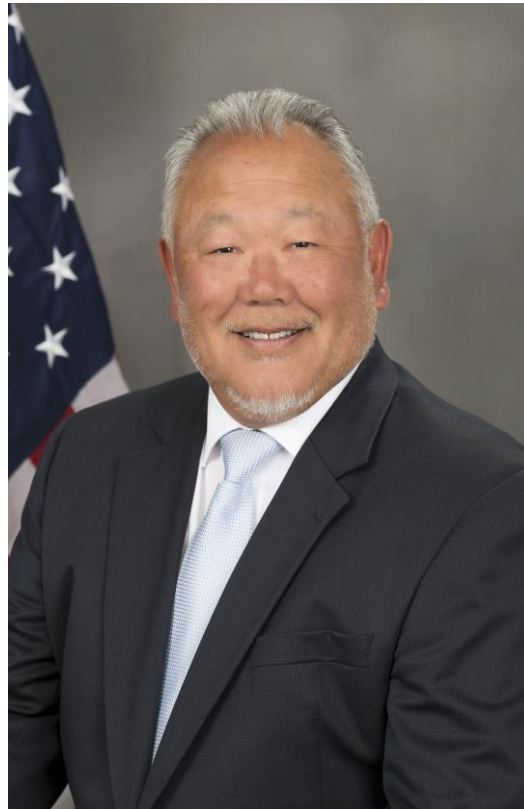

Maximize the independence, well-being, and health of older adults, people with disabilities, and their families and caregivers

Our Vision

All people, regardless of age and disability, live with dignity, make their own choices, and participate fully in society

Administration on Disabilities

- **State Councils on Disabilities**

Gubernatorial appointees charged with identifying needs, advancing public policy and systems change to help individuals gain more control over their lives

- **Protection and Advocacy Systems**

Work at the state level to protect individuals with developmental disabilities by empowering them and advocating on their behalf



Administration on Disabilities

- **University Centers for Excellence in Developmental Disabilities Education, Research & Services**

UCEDDs are a national network of independent but interlinked centers for addressing issues, finding solutions and advancing research

- **Projects of National Significance**

Supports the development of national and state policy and award grants that enhance the independence, productivity, inclusion, and integration of people with developmental disabilities



Administration on Disabilities

- **State Independent Living Councils**

Gubernatorial appointees charged with developing and implementing a state plan to ensure appropriate planning, financial support, coordination and assistance to individuals with disabilities

- **Centers for Independent Living**

Over 500 non-profit centers that are consumer controlled, community-based and cross-disability providing an array of independent living services

National Institute on Disability, Independent Living and Rehabilitation Research (The Institute)

- Supports applied research, training and development activities through comprehensive and coordinated research programs designed to maximize the inclusion, social integration, employment and independent living of individuals with disabilities of all ages

- Enable senior citizens to share a meal, as well as camaraderie and friendship.
- Also provides nutrition education, health screenings, and counseling at senior centers.
- Homebound seniors will receive daily delivery of a hot meal, sometimes by a senior volunteer who is their only visitor.

Disease Prevention & Health Promotion Services

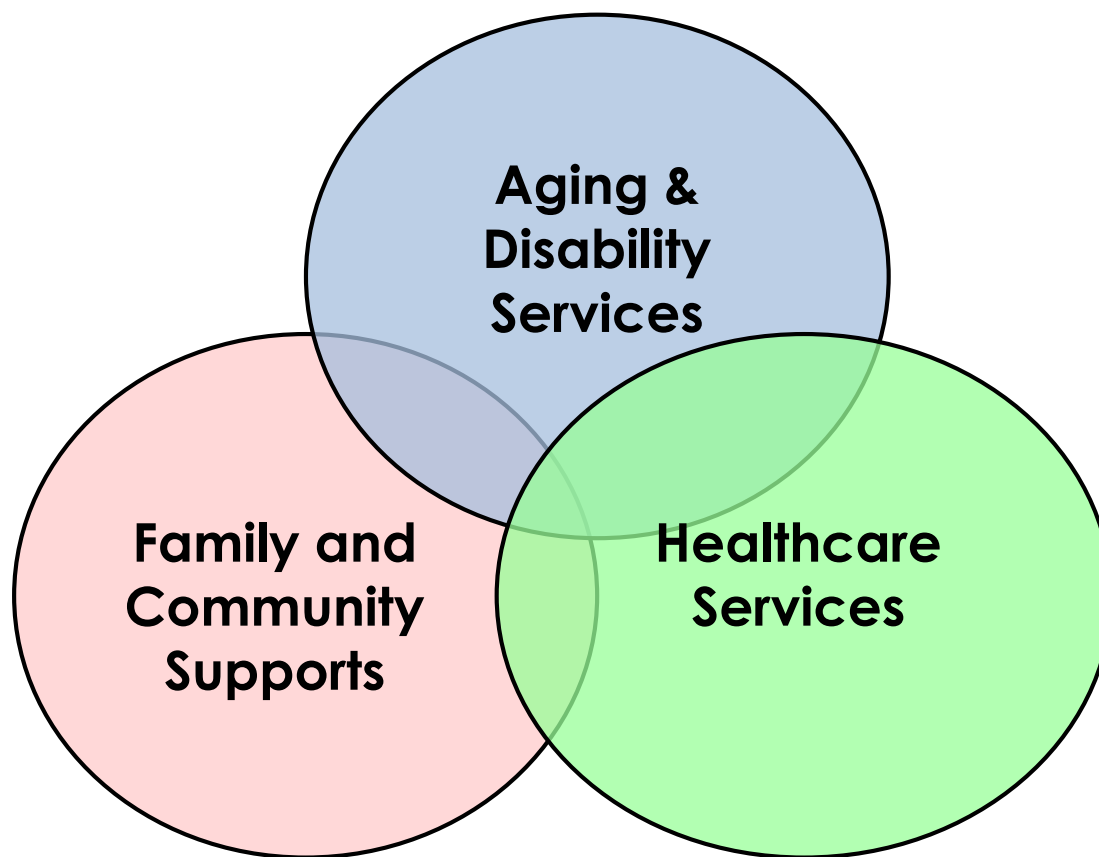
- Educate and enable older persons to make healthy lifestyle choices.

OAA Title III-E:

National Family Caregiver Support Program

- Created to help the millions of people who provide the primary care for spouses, parents, older relatives and friends.
- Services include:
 - ☐ Information to caregivers about available services
 - ☐ Assistance to caregivers in gaining access to services
 - ☐ Individual counseling
 - ☐ Organization of support groups and caregiver training to assist caregivers in making decisions and solving problems relating to their caregiving roles
 - ☐ Supplemental services to complement care - provided by caregivers
