

# PIHOA Board of Directors Considerations

1. Financial support (conference calls, biennial meeting, technical training including SLMTA training).
2. Build local capacity for labs in the USAPIs in the areas of microbiology, hematology, phlebotomy and cyto/histopathology.
3. Develop a qualified and competent laboratory workforce to at least 80% with minimum qualifications by 2022.
4. Recruit qualified lab training officers and or quality officers to serve temporarily as mentors.
5. Build and enhance Tele-histopathology services in the region.
6. Improve laboratory biosafety and infection control in the USAPI labs.
7. Support GPHL Level 2 lab services by increasing the Lab Revolving Funds for each USAPI Lab.
8. Strengthen lab-based surveillance activities during outbreak events.
9. PIHOA to remain as a resource (advisory position & technical support) for the AUL .
