Resiliency

- "The ability to successfully <u>adapt</u> to stressors- to "bounce back" from difficult experiences / trauma.
 - not a trait that people either have or don't have
 - involves <u>behaviors</u>, thoughts, and actions that can be <u>learned</u> and <u>developed</u> in everyone.
 - being adaptable flexibile
 - recognizing that we've got strengths and assets
 - there are <u>metrics</u>, can build
- "Resilience is related to <u>processes and skills</u> that influence good individual and community health outcomes, in spite of negative events, serious threats and hazards." -WHO



Health Security

- public health security
 - activities required, both proactive and reactive
 - to minimize the danger and impact of acute public health events that endanger people's health
 - across geographical regions and international boundaries. -WHO
- measures taken to <u>protect and promote the health of individuals</u>, communities, and nations from threats and hazards.
 - encompasses a range of activities aimed at preventing, detecting, responding to, and recovering from health emergencies, including:
 - Prevention:
 - Surveillance and monitoring of infectious diseases
 - Vaccination programs
 - Promotion of healthy behaviors (e.g., nutrition, exercise)
 - Biosecurity measures to prevent the spread of dangerous pathogens

 - Grants are terminated because values or directives change




Resiliency

- We don't know what we don't know!








Resiliency and Health Security
