## **Exalted Ruler's Message**

One year from now, I will not be Your Exalted Ruler. This Lodge deserves fresh ideas; you will have determined who that will be. So, please join me this year in making fundamental changes for our future. We can choose to go with ideas that have worked in the past and new ideas that we still need to explore.

We can set goals even larger for new membership growth to "exceed" fifty new members. With new applications in the queue, our membership is just under 500 members. That is a far cry from the over 2400 members during the '60s & 70's during NASA's Apollo program to the moon. We might never reach that number again. But NASA is planning to return to the moon. So why can't we also return to that prominence as the largest city in the State of Alabama?

We can act the status quo, like many lodges across our country. Those lodges are closed like the over eighty that did not see the new year or reside at the end of their rope hanging on even now. This past year we lost revenue streams that have supported lodges across this state since the 1960s. We must find new and original ideas for revenue streams that benefit our Lodge while promoting community service and activities here at our club.

As a previous long-time smoker, I understand the risks and enjoyment of smoking. Smoking and non-smoking have been a great debate in establishments for years. I suggest we come together as members this year to see how we can make this a healthier lodge. But how do we accommodate those members that wish to smoke? That must be determined first, and I look at the game room, card room, and patio as ideal alternatives.

On September 12th, I will propose to the Board of Directors, a plan. It will be posted on the bulletin board and emailed to all Elks members. On September 26th at 7 pm, I will read that plan as a motion. It will be up to members attending that lodge meeting on that evening to accept the motion to go non-smoking or remain smoking. "Membership, not leadership, will make this decision."

We are an Elks Lodge and a corporation. We can be a lodge for as long as Elk's Grand Lodge grants us our charter, which in business is a franchise. The corporation consists of President, three Vice Presidents, Secretary, Treasurer, and five Trustees. We all, the members, are the shareholders and control the narrative when you appear to be heard and vote at the Lodge meetings on the second and fourth Tuesday of each month.

I hope you will join me in real change this year. We are deciding now that in twenty years this Lodge will be grander and better than ever before. Members will sit and look at a new exalted ruler then, and by acting now, we have satisfaction in our hearts that we decided to build for their future starting today.

I hope you'll join me in these goals - let's not stop at the moon!

The Club Manager, April Wiggins, and the Cook, James Madaris, have completed the required five year re-certification of the Serve Safe food handling qualification. Current health department score for the kitchen is 94.

On May 5, Cinco de Mayo, the club will offer drink and food specials. On May 6, for Kentucky Derby Day is a "Derby Day Hat Contest", Mint Juleps and BBQ sandwiches for sale. Thanks to the volunteers that help with club operations and special events. Members with ideas or concerns regarding the club may submit them in writing or attend a HC meeting which is the 1st and 3rd Tuesday of the month at 5:30.
