E.R.'s January Newsletter Message to the Membership

Speaking of the new year, it is a reminder that there are only three months left in this term and that election of officers will be coming up with nominations and elections happening soon. With that said, I will be running for Exalted Ruler again as there are many things which are not finished. It has been a year of ups and downs to be sure. Having the previous secretary resign and a new secretary who was brand new to the office has been difficult as we have worked to navigate the learning curve for both of us, myself being a new E.R. The resignation of the chairmen of the golf committee at about the time of the election and having to work to break in new chairmen was not as successful. However, I am in the process of working with a golf committee to look at a tournament toward the end of February or the middle of March to make up the income on the event. We are planning to have a drawdown perhaps in connection with a Mardi Gras event in February if the membership finds it something they want to participate in. Once again, this lodge belongs to the membership, and its officers who are your representatives need your participation in it.

Dear Members Huntsville Elks Lodge 1648:

My name is Dan Barger. Grand Exalted Ruler Robert L. Duitsman by Executive Order has expressed concerns and appointed me as Special Representative to the Huntsville Elks Lodge No. 1648. His Executive Order will be read on the floor by the Lodge Secretary at the January 14, 2020 meeting. Though the situation is serious, it is one that your lodge leadership and I will work to resolve with the least possible interference and disruption. Those primarily involved will include your Board of Directors, Lodge Secretary and Treasurer.

There are nearly 2000 Elks Lodges across the country and the Huntsville Elks Lodge is one of the premiere lodges among these. Huntsville has long been looked upon as a leader in Elkdom. So, when there is a problem or a perceived problem in Huntsville you draw the attention of our State Association and the Grand Lodge. It is in this light that I have been appointed as Grand Lodge Special Representative and asked to provide guidance to your Lodge and its leadership. While here in addition to guidance, I will be evaluating your operations, personnel and adherence to Grand Lodge policies and procedures. I am not an expert; however, I bring a great deal of experience to the table. I am an Elk of forty-four years, three-time Exalted Ruler in two lodges, Past District Deputy Grand Exalted Ruler and I have served in every lodge office except. chaplain. I will avail myself to the charge of ensuring the continued success of the Huntsville Lodge. I will not have all the answers to all of the questions that will arise, but I do have the resources and support to achieve this goal.

Within our organization the Grand Lodge has established a prescribed set of standards, policies and procedures. These are clearly defined in our constitution, statutes and by-laws. These are proven business practices that when followed protect the organization, its members' interest and those individuals charged with the execution of its financial and judicial affairs. They also ensure equity to all members. An Elks lodge adherence to these is not optional. In fact, this adherence is woven into the obligation of our initiatory ritual and the oath taken by every officer.

It appears your lodge has fallen short in adhering to these expectations. This is not to say that what was done was not done in the interest of the lodge. There have been no accusations of theft, defalcation or misappropriation of funds; however, failure to follow protocol could avail questionable transactions to such. During my work in Huntsville I will audit specific transactions in addition to reviewing routine lodge affairs, books and records. To accomplish this, I will rely heavily on the cooperation of lodge officers, trustees and members. This is not a hunting expedition. I, as I am sure you want to identify where any breakdown (if a breakdown) occurred and what can be done to prevent such discrepancy in the future.

I am in your lodge serving you at the request of the Grand Exalted Ruler. I will update you as appropriate and assure you the success of your lodge is of the utmost concern in this process. My email address is dbarger126@comcast.net and I welcome any comment or concern.
