## NHSBA Legislative Update – January 6, 2017

Dear NHSBA Members -

This is the first of NHSBA's regularly distributed Legislative Updates. While the New Hampshire Legislature has not yet begun hearings on bills, this Update contains important information relative to School Building Aid and information relative to all pending bills affecting or impacting school districts and school board governance.

## **Important Message Regarding School Building Aid:**

The New Hampshire Legislature has embarked on its 2017-2018 biennium session. Many issues will come before the Legislature that affect New Hampshire's public schools and school board governance. One vital issue that requires significant school board attention is School Building Aid. The budget process has already begun and the NH Department of Education has requested \$50 million (the maximum allowed by law) for School Building Aid in each year of the biennium.

For the past eight years, the Legislature has suspended any new School Building Aid funding. While the Legislature has continued to fund the "tail" of Building Aid (money for school districts that were eligible to receive such Aid prior to the moratorium), many communities have postponed needed new construction or renovation of aging facilities. Some districts have gone it alone to build new facilities without any State Aid. However, this continued downshifting of costs has placed a heavy burden on the local taxpayers.

NHSBA has long advocated the return of and full funding of School Building Aid. Such advocacy is consistent with NHSBA II:A, II:C, II:D, and II:N – all relative to school funding.

NHSBA advocates that the NH Legislature restore School Building Aid. The state has an interest in and shares responsibility for providing a quality education, which requires safe, efficient facilities in which to learn.

Governor-elect Sununu has expressed support of funding School Building Aid, as has NH House of Representative leadership. However, it is imperative that State representatives hear directly from local school boards and their concerns on the lack of funding. NHSBA urges its members to contact their state representatives, attend legislative hearings, and provide written letters of support for the return of School Building Aid.
