

**Report on AWSS International Conference
on Women and Gender in Russia, 1914-1922
Urbana-Champaign, June 21-24, 2018**

Brought together by their shared interest in gender and women in Russian history, an international group of scholars gathered in June of 2018 at the Summer Research Lab, held every year by the Russian, East European and Eurasian Center (REEEC) at the University of Illinois. Conference participants spent two full days discussing twelve papers that will be published in 2020 as a volume in the series published by Slavica, *Russia's Great War and Revolution, 1914-1922*. The attendees included both the authors of the pre-circulated papers, and up to twenty scholars attending the Summer Research Lab, who greatly enriched discussions with their varied disciplinary and regional perspectives. Enjoying both beautiful summer weather and the exceptional hospitality and support of REEEC and AWSS, all the participants collectively created a conference environment that was intellectually stimulating and mutually beneficial.

Topics ranged from the experiences of Dowager Empress Maria Feodorovna during the war and 1917 Revolution to female journalists in the early Soviet period, and from the employment of women on Russia's railroads during the Great War to the challenges facing disabled veterans at the end of the Civil War. In addition to the rich variety of subjects, the conference was notable for its use of videoconferencing, which enabled authors from the United Kingdom and Russia who could not travel to Urbana-Champaign to present their papers in real time and join in the discussions of their work.

The diversity of topics notwithstanding, conference attendees identified several themes that emerged from this period of Russian history when viewed through the lens of gender. Participants noted, for example, the myriad new opportunities for women to exercise autonomy and agency; yet they simultaneously were relegated to – or often seem to have chosen --- apparently subsidiary, service roles. Women's strong sense of patriotic duty to the nation or the revolution competed with their duties to family in deteriorating economic conditions or to their religious faith, as explored in one paper on Orthodox women pilgrims. Several papers explored masculinity during this period, a topic well studied by historians of European combatants in the Great War but barely touched on for Russia.

The conference co-organizers and co-editors of the volume in preparation are Melissa Stockdale of the University of Oklahoma, AWSS Secretary, and Adele Lindenmeyr, Villanova University.
