FREQUENTLY ASKED QUESTIONS

1. How do I sign up for the program if I don't have access to email?

2. How would I know if I am on PTC?

We will review your bill to let you know.

3. What if I'm not on PTC?

You may still be paying too much for your electricity supply. We can review to let you know if your current rate is competitive, if you're currently under contract, and when that contract ends.

4. What if I am participating in the government aggregation program?

Some programs offer fixed rates or a percent off price to compare. If you are on a percent off program, your rates will increase during that timeframe. If you are unsure what type of program you are participating in, send us your bill and we can help you determine this.

5. Do I need to be a member of the chamber to sign up for this energy savings program?

No. You do not need to be a member. The Chamber is a resourceful advocate for the community and is making its discounted electricity rates available to members and non-members.

6. Why is the Chamber doing this?

With the unfortunate circumstances of COVID-19, the Chamber sees an opportunity to share its Chamber Energy Program with the community, providing local businesses with an immediate opportunity to reduce their costs.

7. I do not own a business. Can I still sign up?

We are only able to provide this offer to commercial customers at this time.

8. Are there any upfront costs to enroll?

The chamber does not charge for this service.

9. Will I receive a separate bill from my new supplier once I switch?

No, you will continue to receive only one bill from your local electric utility company. You will see your new supplier's discounted rate listed on your bill.

10. What term is the exclusive rates through the Chamber Energy Program?

It's your choice! The Chamber Energy Program is offering exclusive rates for 18, 24, or 36 months that start at your first available meter read and can be viewed online at chamberenergyprogram.com/enrolltoday. Offers may change daily. Your actual rates will depend on the supply agreement that you choose and the terms of that agreement.

11. What happens when my new contract with the Chamber Energy Program ends?

The Chamber Energy Program will reach out to you when it is time to renew.

12. Who is Community Energy Advisors (CEA)?

CEA manages the Chamber Energy Program offered to over 200 Chambers of Commerce in partnership with NOACC and SOCA.

THIRD PARTY AUTHORIZATION TO ENROLL

Bulk Electricity & Natural Gas Buying Group

This Authorization is given on _____ by _____ ("Customer") to Community Energy Advisors, LLC ("CEA"), the coordinator of a bulk Electricity & Natural Gas Buying Group comprised of multiple commercial entities ("Group").

This Authorization declares Customer's appointment of CEA as its exclusive, authorized agent to act on behalf of Customer and to secure electricity and natural gas rates for Customer's accounts. Customer hereby declares and gives CEA approval to act on Customer's behalf with regard to inclusion of Company in the Group for purposes of negotiating, transacting and executing agreements with third-party suppliers involving the purchase electricity and natural gas products. Customer authorizes CEA to secure these energy supply products for an initial and subsequent renewal terms, each up to a term of 48 months.

Customer acknowledges and agrees that CEA may provide to third-party suppliers Customer information needed to secure electricity and natural gas pricing and gives permission to CEA to sign supply agreements with certified retail natural gas and electric suppliers on Customer's behalf. Customer authorizes suppliers to obtain Customer's usage information from its utilities. Customer authorizes the release of all current contract information between Customer and supplier, as requested by CEA. CEA will make available to Customer a prototype of agreements from prospective suppliers for Customer's review. Customer understands that a Transaction Confirmation ("TC") will be sent to Customer with details of all agreements signed on Customer's behalf. Once enrolled by the retail supplier, customers other than those defined as Mercantile shall have the right to rescind their enrollment with the retail supplier within seven calendar days following the postmark date on the utility's confirmation notice.

Customer understands it (1) will be bound by any electricity and natural gas agreements signed on Customer's behalf as if it were signed by Customer; (2) will remain responsible for all obligations incurred on its behalf by CEA; (3) shall indemnify and hold harmless CEA and any contracted third-party supplier against claims, losses, liability or expenses as a result of actions performed by CEA under this Authorization, including any early cancellation fees; (4) shall contact any current supplier(s) and provide notice of termination, if necessary, based upon enrollment by Customer's new retail supplier. Customer agrees to provide CEA with all information necessary for CEA to act as Customer's agent, including, but not limited to, all information relating in any way to Customer's utility account(s), utility programs, energy requirements, energy supply agreements, and energy usage. Customer acknowledges that CEA does not guarantee any particular outcomes or results. Customer further acknowledges that changes to applicable laws, rules or utility programs may adversely impact Customer, and CEA is not responsible for any such changes or impacts.

The term of this Authorization shall be one year and will renew annually for additional one year terms unless Customer terminates the Authorization at least thirty (30) days prior to the end of the initial or any renewal term. CEA will notify Customer in writing at least 30 days prior to the expiration of all agreements and transactions made on behalf of Customer through the Group.
