Data Collection & Reviewing Key Indicators

- FR-CARA only: 25,297 doses distributed, and 2,158 individuals trained since the beginning of the grant, September 29, 2022.
 - We're already at 95% of our 4-year deliverable (26,740 doses) under the FR-CARA grant (ending Sept 2026).
- FR-CARA & SOR: 140,318 doses distributed, and 3,353 individuals trained since September 29, 2022.
- Since September 30th, 2022: 2,396 individuals took the post-naloxone training questionnaire
 - 85.2% feel very confident recognizing the signs of an overdose
 - 91.3% feel very confident understanding of the three steps to administer naloxone
 - 89.7% feel very confident administering naloxone to reverse an overdose
 - 83.6% feel very confident understanding opioids and their effects
- Since September 30th, 2022: 547 reports of individuals using SNHD's naloxone to reverse an overdose.
 - 85.0% reported 1-2 doses were needed
 - 15.0% reported 3 or more doses were needed
 - 86.3% reported naloxone was used on men
 - 93.7% survived

Program Updates

Training

- We want to remind partners that we recommend refresher overdose response training every 2 years.
- We will soon have an updated PowerPoint to provide to agencies that have attended the Training of Trainers. We will send an email when it's ready.

Program Updates

Reclaimed Naloxone

Multiple agencies have been returning naloxone to us *before it expires*.

Once we receive this, the undamaged doses are redistributed to community before it expires.

So far this year, our partners have helped us save nearly 1000 doses of naloxone. We have reclaimed 996 doses. At today's pricing, that is a savings of roughly \$15,438.


