Data Collection Strategies for SDOH, SOGI, HIV, Race & Ethnicity

This session will focus on identifying the who, what, how, & when of data collection related to SDOH, SOGI, HIV status, race and ethnicity....

Who should be collecting the data? Do we have the appropriate team member(s) collecting the data - and have they received adequate training related to this aspect of their role?

What data is being collected? Are we asking the right questions?

How is the data collected? Is it being captured or documented in a standardized way in order to facilitate the necessary follow up?

When in the workflow is the data collection occurring? Are we ensuring privacy, confidentiality and demonstrating cultural competence in our processes?

Participants will obtain an understanding of:

- 1. The importance of having a clearly defined process related to collection and documentation of SDOH, SOGI, and other PHI
- 2. Considerations for training and competencies related to demonstrating and eliciting trust and mutual respect with patients regarding PHI (ie: motivational interviewing, etc)
- 3. The significance of maintaining privacy and confidentiality throughout the process

Motivational Interviewing Techniques to Support SDOH, SOGI, and Race & Ethnicity

This session will focus on fostering a high trust environment, demonstrating an understanding of population specific terminology and using communication to decrease barriers.

- 1. Concepts and principles of motivational interviewing to promote a high trust environment for patients and their support systems
- 2. Increasing staff skills and comfort level related to providing culturally competent care
- 3. Population specific terminology to ensure a safe, affirming, and engaging environment for all patients

Meaningful Data Utilization - Going beyond data collection and data entry

This session will focus on utilizing essential data meaningfully in order to improve health equity, inclusion, and diversity of services.

Participants will obtain an understanding of:

- 1. Definitions and differences between equity and equality, inclusivity, diversity and disparity and the role of the health center in providing services consistent with diversity, equity and inclusion
- 2. HRSA mandated expectations related to utilization of patient reported data and needs assessments as a driver of service provision
- 3. The criticality of assessing patient reported data and using it meaningfully to trigger actions and workflows targeted at meeting patient needs, mitigating risk factors, and improving outcomes
