

Notes on offense references: Listed offenses in the following tables are selected Title 11 felonies explicitly referencing firearms or ammunition, and weapon offenses where uncertainties often arise as to specificity of the type of weapon or prohibited object based solely on entered charge data. It is important to note that improperly referenced charges among these offense types are not uncommon in arrest and court data. Person prohibited charges under § 1448 are separated into three groups. Charges labeled as felony grades D, C, or B, except charges entered with subsection (a)(9) references, are counted within the “Firearm/ammo” row. (Ammunition possession offenses counted in this group cannot be distinguished from firearm possession based on charge references.) Charges entered with subsection (a)(9) references, regardless of felony class, are counted in the “Auto/Semi-auto/Handgun & Drug” row. Charges other than subsection (a)(9) labeled as class F felonies are counted in the “Deadly Weapon” row.

Notes on column headings: Disposition Pending or Unknown may include some charges that were disposed, with or without convictions, but dispositions were not entered in the system. Counts in the Nol-prossed or Dismissed column include some charges that were nol-prossed for disposition in another court, which can include possible conviction in the Federal system. PBJ or Diversion includes Probation Before Judgment or Diversion that may be completed; Nol-prossed or Dismissed may include charges that were nol-prossed or dismissed after diversion.
