Networking Events

Sponsor one of the Chamber's fastest growing networking events! One networking event will be held each month on the 2nd Tuesday, alternating between morning Coffee & Conversation and evening After Hours. For each event, your business has the opportunity to be the host, hosting sponsor, networking sponsor, or both. Sponsorships should be requested two months in advance for optimal visibility.

Coffee & Conversation

This event is typically held from 8:00 – 9:00 AM at the Hosting Sponsor's business. This event is available to Chamber members and other local business-minded individuals. This event typically generates 20 – 30 participants; depending on the sponsorship selected, we ask that you can comfortably accommodate the number of participants.

Host – Free for Members (\$50 Non-Member)

The Host should:

- ☐ Provide coffee for attendees (additional food and beverages are optional).

What is the benefit?

- ☐ Showcase your business's facility, products, and services to a captive audience!
- ☐ Includes business name on all event promotional materials.

Event Sponsor – \$150 for Members (\$200 Non-Member)

The Event Sponsor should:

- ☐ Arrive approximately 30 minutes prior to the event for set-up.
- ☐ Prepare an optional 3 – 5 minute welcome speech.
- ☐ Provide a small door-prize or giveaway at the event (optional).

What is the benefit?

- ☐ Includes business logo on all event promotional materials.
- ☐ The event with your logo is featured in the Chamber Newsletter, on social media, and on the Chamber's Community Events Calendar.
- ☐ Set up a table to share information about your business with a captive audience!
- ☐ You have the option to welcome attendees with a 3 – 5 minute welcome speech OR let us recognize your business as the event Sponsor.
- ☐ Your welcome speech is shared via Facebook Live.
- ☐ Photos taken during the event and shared on social media.

Business After Hours

This event is typically held from 5:00 – 7:00 PM. This event is available to Chamber members and other local business-minded individuals. This event typically generates 30 – 50 participants.

Host – Free for Members (\$50 Non-Member)

The Host should:

- ☐ Provide one complimentary beverage (wine, beer, and nonalcoholic). Additional beverages may be purchased by the guest.
- ☐ Provide complimentary light hors d'oeuvres.

What is the benefit?

- ☐ Showcase your business's facility, products, and services to a captive audience!
- ☐ Includes business name on all event promotional materials.

Event Sponsor – \$150 for Members (\$200 Non-Member)

The Event Sponsor should:

- ☐ Arrive approximately 30 minutes prior to the event for set-up.
- ☐ Prepare an optional 3 – 5 minute welcome speech.
- ☐ Provide a small door-prize or giveaway at the event (optional).

What is the benefit?

- ☐ Includes business logo on all event promotional materials.
- ☐ The event with your logo is featured in the Chamber Newsletter, on social media, and on the Chamber's Community Events Calendar.
- ☐ Set up a table to share information about your business with a captive audience!
- ☐ You have the option to welcome attendees with a 3 – 5 minute welcome speech OR let us recognize your business as the event Sponsor.
- ☐ Your welcome speech is shared via Facebook Live.
- ☐ Photos taken during the event and shared on social media.

Lunch & Learn

This event is typically held from 11:30 AM – 1:00 PM. This event is available to Chamber members and other local business-minded individuals. The Chamber organizes a guest speaker to lead a workshop or seminar on a relevant business topic. This event typically generates 25 – 40 participants.

Host – Free for Members (\$100 Non-Member)

The Host should:

- ☐ Provide adequate space to comfortably accommodate attendees.

What is the benefit?

- ☐ Showcase your business's facility, products, and services to a captive audience!
- ☐ Includes business name on all event promotional materials.
- ☐ Includes two complimentary tickets to the event.

Event Sponsor – \$200 for Members (\$250 Non-Member)

The Event Sponsor should:

- ☐ Arrive approximately 30 minutes prior to the event for set-up.
- ☐ Prepare an optional 3 – 5 minute welcome speech.
- ☐ Provide a small door-prize or giveaway at the event (optional).

What is the benefit?

- ☐ Includes business logo on all event promotional materials.
- ☐ The event with your logo is featured in the Chamber Newsletter, on social media, and on the Chamber's Community Events Calendar.
- ☐ Set up a table to share information about your business with a captive audience!
- ☐ You have the option to welcome attendees with a 3 – 5 minute welcome speech OR let us recognize your business as the event Sponsor.
- ☐ Your welcome speech is shared via Facebook Live.
- ☐ Opportunity to introduce the speaker.
- ☐ Photos taken during the event and shared on social media.

Annual Events

Annual Meeting

The Annual Meeting is a time of celebration and reflection on the past year, what the current state of the Chamber is, as well as where the Chamber is headed. Attendees will hear from the Chairman of the Chamber Board of Directors, the Chamber leadership, as well as the Chamber program leaders.

Program Sponsor - \$100

The Sponsor should:

- ☐ Request sponsorship no less than 30 days in advance.
- ☐ Provide high-resolution logo in JPEG, JPG, or PNG format.

What is the benefit?

- ☐ Sponsor recognition on the event program.
- ☐ Recognition from the stage.

Bluffton Ball

The Bluffton Ball is the Greater Bluffton Chamber's signature event to recognize and honor outstanding local businesses who have made substantial contributions to the success of the Greater Bluffton community. Award categories will be determined each year.

Presenting Sponsor - (1 available)

The Sponsor should:

- ☐ Request sponsorship no less than 60 days in advance.
- ☐ Provide high-resolution logo in JPEG, JPG, or PNG format.

What is the benefit?

- ☐ Sponsor logo is prominently featured on all event promotional material.
- ☐ Sponsor recognition on the event information shared on social media as well as the Calendar of Events (link to company website).
- ☐ Sponsor display at registration.
- ☐ Recognition from the stage.
- ☐ Opportunity to provide a 5 – 7 minutes welcome speech.
- ☐ Reserved seating for eight (8).

Additional Sponsorship Tiers will be determined by the Event Committee

Benefits May Include:

- ☐ Sponsor logo is featured on all event promotional material.
- ☐ Sponsor recognition on the event information shared on social media as well as the Calendar of Events (link to company website).
- ☐ Recognition from the stage.
- ☐ Sponsor will assist in presenting the award to the winner at the event.

Programs

Chamber Ambassadors

Chamber Ambassadors are the "arms and legs" of the Chamber's activity in the community. They actively represent the Chamber's mission of serving the community and supporting local businesses in various ways.

Bluffton Chamber Young Professionals

The Bluffton Chamber Young Professionals (BCYP) is the premier Young Professionals group for the Greater Bluffton area, which focuses on developing strong, local leaders who enhance the community by helping them strengthen necessary personal and professional skill sets. Each month, BCYP holds a networking event that engages the area young professionals with the broader business community to help them establish a local, professional network and equip them to give back to the community.

Host – Free for Members (\$50 Non-Member)

The Host should:

- ☐ Provide one complimentary beverage (wine, beer, and nonalcoholic). Additional beverages may be purchased by the guest.
- ☐ Provide complimentary light hors d'oeuvres (optional).

What is the benefit?

- ☐ Showcase your business's facility, products, and services to area Young Professionals.
- ☐ Includes business name on all event promotional materials.

BCYP Monthly Meet – Up Sponsor - \$200

The Sponsor should:

- ☐ Request sponsorship no less than 45 days in advance.
- ☐ Provide high-resolution logo in JPEG, JPG, or PNG format.

What is the benefit?

- ☐ Approximately 35 – 40 area Young Professionals.
- ☐ You have the option to welcome attendees with a 2 – 3 minute welcome speech OR let us recognize your business as the Sponsor.
- ☐ Includes business logo on all event promotional materials.
- ☐ The event promotional materials are featured in the Chamber Newsletter, on social media, and on the Chamber's Community Events Calendar.
- ☐ Two complimentary tickets to attend the event.
- ☐ Greet and network with attendees during the event.
- ☐ Opportunity to provide business promotional materials (business cards, promotional items, informational brochures, etc.), which can be displayed at the registration/check-in table.
- ☐ Photos taken during the events and shared on social media (with sponsorship recognition).
- ☐ Recommended, but not required: Provide a giveaway for the event.

- ☐ Provide high-resolution web banner (480 x 125) in JPEG, JPG, or PNG format.
- ☐ Provide website address for your banner to link to.

What is the benefit?

- ☐ Your company web banner ad (480 x 125) will be visible on each of the Chamber's Web pages.
- ☐ Your web banner will link directly to the website of your choice.

Page Sponsor – \$200 Annually

The Sponsor should:

- ☐ Request sponsorship no less than 30 days in advance.
- ☐ Provide high-resolution web banner (480 x 60) in JPEG, JPG, or PNG format.
- ☐ Provide website address for your banner to link to.

What is the benefit?

- ☐ Your company web banner ad (480 x 60) will be placed on one of the following pages: Directory Search, Events, News Releases, Jobs
- ☐ Your web banner will link directly to your business website.

Category Sponsor – \$100 Annually

The Sponsor should:

- ☐ Request sponsorship no less than 30 days in advance.
- ☐ Provide high-resolution web banner (480 x 60) in JPEG, JPG, or PNG format.
- ☐ Provide website address for your banner to link to.

- ☐ Your listing will be displayed and highlighted at the top of the listings within the category.

The e-newsletter contains important business-related information, upcoming Chamber events and Ribbon Cutting Celebrations, Member Spotlights, Chamber Leadership Features, Benefits, Community News, and much more. Limited to three per week.

Weekly Sponsor - \$50

Monthly Sponsor - \$150

Quarterly Sponsor - \$350

The Sponsor should:

- ☐ Request sponsorship no less than two weeks in advance.
- ☐ Provide high-resolution web logo in JPEG, JPG, or PNG format.
- ☐ Provide website address for your logo to link to.

What is the benefit?

- ☐ Your business name/logo appears prominently on the Chamber weekly newsletter.
- ☐ Your logo will link to the website of your choice.
- ☐ Sent to more than 2,300 friends of the Chamber every week.

Membership Packet

New and Prospective Member Packet - \$300

Each prospective member and new member will receive a packet of indispensable information from the Greater Bluffton Chamber of Commerce.

What is the benefit?
