1 **A RESOLUTION URGING THE HOUSING AUTHORITY OF FULTON COUNTY,**
2 **GEORGIA AND THE ATLANTA HOUSING AUTHORITY TO PARTICIPATE IN**
3 **DEVELOPING A PLAN TO JOINTLY ENGAGE IN AFFORDABLE HOUSING**
4 **INITIATIVES, PROJECTS, AND PROGRAMS, ALONG WITH IMPLEMENTING**
5 **POLICIES TO SUPPORT AFFORDABLE HOUSING; AND FOR OTHER**
6 **PURPOSES.**

7 **WHEREAS**, the lack of available affordable housing is impacting all communities
8 throughout the United States; and

10 **WHEREAS**, the Board of Commissioners is unwavering in its support of
11 providing increased quality affordable housing for the citizens and residents within all
12 municipalities of Fulton County, Georgia; and

13 **WHEREAS**, the Housing Authority Law of the State of Georgia (O.C.G.A. §8-3-1
14 *et seq.*) creates a Housing Authority in each county and municipality within the state,
15 subject to activation by the local governing authorities; and

16 **WHEREAS**, the Fulton County Board of Commissioners activated the Housing
17 Authority of Fulton County, Georgia, via resolution, on January 19, 1972, for the
18 purpose of addressing a shortage of safe or sanitary dwelling accommodations
19 available to low-income citizens within Fulton County; and

20 **WHEREAS**, the Atlanta City Council passed a resolution establishing the Atlanta
21 Housing Authority on May 18, 1938; and

22 **WHEREAS**, the Housing Authority of Fulton County, Georgia provides affordable
23 housing options throughout Fulton County for citizens with low to moderate incomes,
24 and administer programs that promote economic development, sustained livability and
25 self-sufficiency; and

1 **WHEREAS**, the Atlanta Housing Authority provides and facilitates affordable
2 housing resources for nearly 22,000 low income households comprised of
3 approximately 50,000 people within the City of Atlanta; and

4 **WHEREAS**, pursuant to O.C.G.A. §8-3-13(a), any two or more housing
5 authorities may join or cooperate with each other to exercise any or all of their
6 enumerated powers for the purpose of planning, undertaking, constructing, operating, or
7 contracting with respect to a housing project or projects located within the area of
8 operation of any one or more of said housing authorities; and

9 **WHEREAS**, to address the lack of affordable housing within Fulton County and
10 the City of Atlanta, the Board of Commissioners of Fulton County finds that collaboration
11 between the Housing Authority of Fulton County, Georgia and the Atlanta Housing
12 Authority on leveraging resources on joint projects and services that will benefit Fulton
13 County as a whole in responding to the increasing need of affordable housing; and

14 **NOW, THEREFORE, BE IT RESOLVED**, that the Board of Commissioners of
15 Fulton County hereby urges the Housing Authority of Fulton County, Georgia and the
16 Atlanta Housing Authority to participate in developing a plan to jointly engage in
17 affordable housing initiatives, programs and projects, along with implementing policies
18 to support affordable housing for low and moderate income families, and to explore joint
19 programs and to respond to the increasing need of affordable housing throughout
20 Fulton County, including the City of Atlanta; and

21 **BE IT FURTHER RESOLVED**, that the Clerk to the Commission is hereby
22 directed to send a copy of this Resolution to the Housing Authority of Fulton County,

1 Georgia and the Atlanta Housing Authority upon approval by the Board of
2 Commissioners of Fulton County.

3 **BE IT FINALLY RESOLVED**, that all Resolutions and parts of resolutions in
4 conflict with this Resolution are hereby repealed to the extent of the conflict.
