REGISTRATION MATERIALS:

1. Registration letter and general information
2. FACTS registration and tuition payment procedure
3. Family enrollment contract
4. Volunteer service hours (requirements & general information)

RETURN OF CONTRACT:

A student is officially registered and has a spot held in the classroom when the applicable contract and agreement are signed and returned to the school office.

REGISTRATION / SCHOOL SUPPLY FEE (*non-refundable, due at time of registration*):

A registration fee of **\$300** (per child) will be deducted from FACTS on April 1, 2022 if registered by **March 15, 2022** **Early Bird Rate!**

A registration fee of **\$350** (per child) will be deducted from FACTS on April 15, 2022 if registered by **April 1, 2022**

A registration fee of **\$400** (per child) will be deducted from FACTS if registering after **April 1, 2022**

GRADUATION FEE (8th grade only): \$75 covers Mass stipend, diploma, gown, flowers, program, pianist, and invitations

TUITION RATES:

The Finance Committee has reviewed and approved the rate schedule for 2022-2023. Every effort is made to keep tuition affordable for all families. A lower rate is offered for families committing to 35+ volunteer hours during the 2022-2023 school year.

FUNDRAISING INCOME:

We are able to offer reduced tuition and lower rates than the budgeted cost per child if we generate the difference through fundraising income. In order to provide lower rates with a balanced budget, we need to raise approximately \$60,000 from the Great Cash Giveaway/Gala (11/5/22) and \$15,000 from the spring Walkathon.

All families are required to contribute to the school budget through ticket sales. If all tickets are not sold or purchased, the remaining balance will be added to the tuition balance and pro-rated over the remainder of the school year contract. There is the option of paying for the Great Cash Giveaway "Family Dozen" raffle tickets with a monthly charge of \$75 for four months (July, August, September & October) for a total of \$300.

Return of Contract:

A student is officially registered when the applicable contract is signed and returned to the school office.

- Registration fees will be deducted from FACTS within 15 days of receiving this completed contract.
- All families must register on FACTS at the time of registration.

Tuition Rates:

The Finance Committee has reviewed and approved the rate schedule for 2022-2023. Every effort is being made to keep tuition rate increases to a minimum. We want our school to be affordable for all families.

*Tuition Assistance is available to families that qualify. Applications are to be submitted via FACTS.

TUITION POLICY

1. Families have 2 options to pay tuition:

- Full Payment: If using this option the entire amount of tuition is paid directly to the school on July 1st through FACTS.
- Monthly Option: If using this option the entire amount of tuition is paid monthly over a 10 or 12-month period beginning in July (12-month option) or September (10-months option). This would be paid through FACTS Management Company. With this option, the family authorizes their bank to transfer the tuition payment from a checking or savings account, or credit card, on the 5th or 20th of each month. FACTS terms and conditions will apply regarding missed payments, etc. (see FACTS Enrollment Form).

2. If tuition is delinquent, the following may apply according to the Academy school policy:

- a. report card will not be issued
- b. the student may not be permitted to continue enrollment if tuition is delinquent 60 days
- c. eighth-grade students will not be permitted to participate in graduation activities
- d. the student will not be permitted to re-register for the following year

3. Late Registration: Families registering after July 1st shall be expected to fulfill their tuition obligations according to the tuition policy Rate 1, stated previously. Tuition for students registering on or after the first day of school shall be prorated accordingly.

4. Transfers:

If a student transfers to another school after registration is complete, the family must pay the following: (1) FACTS Service Fee of \$50 and (2) tuition for the entire month in which the student is leaving. **No records will be transferred to the other school until these requirements are met.**

4. Select a payment plan option.
5. Enter the proper demographic information and create a username and password.

Once you have set up your online payment plan with FACTS and created your username and password, you have the ability to view and update your payment plan online at <https://online.factsmgt.com>.

You will be notified by e-mail or letter regarding confirmation of the monthly tuition payment for the 2022-2023 school year. **Tuition payments begin July 2022 and end June 2023 with a 12-month payment plan (or September 2022 with a 10-month payment plan).**
