



## Terms & Conditions

**Eligibility** - The Dream Room Makeover Sweepstakes (the "Sweepstakes") is open only to those who sign up at the online sweepstakes page and who are homeowners with their primary residence in Massachusetts that are 18 years of age as of the date of entry. The sweepstakes is only open to legal residents of the United States and is void where prohibited by law. Employees of A.J.
