### *Current Situation*

Firefighters worked aggressively overnight strengthening and improving containment lines. Minimal fire activity was observed near the perimeter however, an increase in wind gusts after midnight caused occasional burn out of unburned islands of vegetation well within the fire's perimeter.

EFFECTIVE 06/25/18 at 7:00 p.m. Evacuations are lifted for the following streets: All roads off Heavenly Valley, all roads off Oak St., All roads off China Gulch, All residents on Cloverdale Rd. between Clovermarie Ln. and Oak St., All roads off Gas Point Rd. south of Clear Creek Rd., All residents on Cloverdale Rd. west of the Cloverdale Trailhead.

Evacuations: All residents within the road closure area remain under evacuation order: Clear Creek Rd. between Honeybee Ln. at the east end and the county transfer station on the west end, Cloverdale Rd. between Clovermarie Ln. at the southeast end and the Cloverdale trailhead at the northwest end.



**Evacuation Shelter:** West Valley High School 3805 Happy Valley Road

**Road Closures:** Clear Creek Rd. between Honeybee Ln. at the east end and the county transfer station on the west end, Cloverdale Rd. will remain closed between Clovermarie Ln. at the southeast end and the Cloverdale trailhead at the northwest end.
