 [redacted] has been receiving occupational therapy services for 90 minutes per month since the beginning of the school year. The focus during occupational therapy has been on his visual motor skill and fine motor skills. [redacted] continues to demonstrate difficulties with regards to his visual motor skills. Specifically with handwriting legibility and spatial organization of written material. Previously, [redacted] had an IEP for a speech and language impairment. [redacted] was released from special education services on May 8, 2017.
