**OVERVIEW:**

The Superintendent's Proposed FY 2021 Capital Budget is the first step in the annual capital budget process which will conclude with the approval of the Board of Education's final Capital Budget in May 2020. The Capital Budget is submitted much earlier than the Operating Budget to accommodate deadlines associated with submission of the State Capital Budget. The Board of Education must approve the capital budget request state priority listing prior to its submission to the State by the October due date to apply for state funding for eligible projects in the FY 2021 Capital Budget. A copy of the state priority list is attached. The capital budget priority list is developed based upon criteria for State participation and assessed capital needs presented in the Superintendent's Proposed FY 2021 Capital Budget.

Provided is the originally planned Superintendent's Proposed Capital Budget dated September 5, 2019, which was developed to advance the Board's priorities based on the approved FY20 Capital Budget. Also, provided is the revised Superintendent's Proposed Capital Budget dated September 10, 2019 reflecting anticipated County funding levels. The state priority listings for each Capital Budget are also included.

**RECOMMENDATION/FUTURE DIRECTION:**

The Board will be asked to approve the FY 2021 Capital Budget request and state priority listing for submission to the State at the September 19, 2019 Board meeting.
