



PARKS REOPENING FAQs

WHEN ARE PARKS REOPENING?

The City will open parks in gradual phases. Phase 1 will be implemented Monday, May 18, 2020.

WHAT ARE THE PARK HOURS?

The park hours during Phase 1 are 8:00 am to 6:00 pm seven (7) days a week.

ARE ALL MIRAMAR PARKS OPEN?

No, Phase 1 only includes the opening of 11 parks. Those parks are:

- Beauty Park 6400 Miramar Parkway
- Harbour Lakes Park 18441 SW 25 Street
- Huntington Entrance Park 14850 Lakeside Drive
- Linear Park North 2500 Utopia Drive
- Linear Park South 3500 Utopia Drive
- Monarch Lakes Park 2150 SW 136 Avenue
- Progress Park 6401 Miramar Parkway
- River Run Park Walking Trail Only 9500 Miramar Blvd.
- Shirley Branca Park 6900 Miramar Parkway
- Veteran's Memorial Park 6405 Arbor Drive

WHAT ACTIVITIES CAN BE DONE AT THE PARKS?

The parks are available for walking, biking, jogging, exercising and enjoying nature and the outdoors.

WILL PLAYGROUNDS BE OPEN?

Playgrounds will remain closed. The date for re-opening has not been determined.

WILL RESTROOMS BE AVAILABLE AT THESE PARKS?

Restrooms will remain closed until we can ensure that the level of sanitation recommended for park restrooms by the CDC can be adhered to.

PARKS REOPENING FAQs (continued)

WILL THE BASKETBALL COURTS BE OPEN?

Basketball courts remain closed. The reopening date has not been determined.

ARE FACE COVERINGS REQUIRED IN THE PARKS?

Yes, face coverings are required in the parks.

CAN I VISIT THE PARK WITH MY FAMILY?

Yes, as long as you comply by wearing facial coverings, your group is not more than 10 people and you observe social distancing.

WHO WILL BE ENSURING GUIDELINES ARE BEING FOLLOWED?

Depending on the park, there will be stationary and rotating staff monitoring the parks. The City's Police Department will be collaborating with Parks staff to ensure compliance.

WHAT IF I SEE SOMEONE NOT COMPLYING WITH THE PARK GUIDELINES?

Please report violations to park staff or call 954-602-HELP.

WHEN WILL MORE PARKS BE OPENED?

During Phase 2, more parks will open.

WHEN IS PHASE 2?

The Phase 2 implementation date has not been set. It will be determined as we assess the trend of cases in Miramar and the compliance of recommended guidelines by parks users as we are responsible.

WHAT CAN WE EXPECT DURING PHASE 2?

The plan has not been finalized, but the areas that are being considered are the pools at the aquatic centers and sports fields. There will be limitations and guidelines placed following CDC recommendations for each to assure adherence and safeguard all users as best as possible.
