# Doors

**Doors** A critical component of school safety is to ensure that doors are never propped or held open.

CISD has conducted a safety audit to ensure all exterior and interior doors are in working order and function appropriately.

The expectation in CISD is that all doors are to be locked and never propped or held open.

Classroom doors will remain locked throughout the day.

All visitors to campus must enter through the main entrance with a valid ID.

Students and staff will not open any exterior door to anyone wanting to gain access to a campus.



**SROs** A critical component of school safety is to ensure highly skilled and trained school resource officers are present at every campus.

Thanks to the partnership with the City of Southlake, Carroll ISD has armed School Resource Officers (SROs) at every school with extensive training on school safety.

CISD works closely with local law enforcement to address safety and security issues that may occur within the district and have implemented additional security measures.

SRO officers have partnered with campus and district leadership in training all staff on Standard Response Protocols.



# **ID** Badges

**ID Badges** A critical component of school safety is to ensure proper identification of adults and students on campus.

It is vital to know who is on our campuses at all times

Visitors are required to wear Raptor stickerbadges at all times while on campus.

Staff at all campuses and students in grades 5-12 wear district issued ID badges at all times while on campus. Exceptions include when students are participating in:

- Extracurricular Athletics and Fine Arts Classes, Practices, and/or Events
- o PE Classes
- o Recess



## **Stoplt** A critical component of school safety is to ensure students, staff, and families have a method to report any concern and/or incident regarding the safety and security of our campuses.

# Stopit

All students and staff may use an anonymous reporting system to share information regarding incidents or safety concerns as soon as possible. See Something, Say Something!

Download the StopIt app to report incidents that go directly to campus administrators, police officers, and other personnel who can immediately respond to the report.

#### Campus Check In - Visitor Protocols A critical component of school safety is to ensure robust systems and procedures for all visitors on a campus.

When large events are scheduled during school hours to occur on campuses, visitors will be provided an online form to complete in advance of the event in order to reserve a pre-printed visitor's badge.

These badges will be available for pick up on the day of the event. Be prepared to show your ID every time you visit a CISD school, even if pre-registered.

#### **Standard Response Protocols**



**Hold** is followed by the Directive: "**In Your Room or Area**" and is the protocol used when hallways need to kept clear of occupants.



**Secure** is followed by the Directive: "**Get Inside. Lock Outside Doors**" and is the protocol used to safeguard people within the building.



**Lockdown** is followed by "**Locks**, **Lights**, **Out of Sight**" and is the protocol used to secure individual rooms and keep occupants quiet and in place.



**Evacuate** and may be followed by a location, and is used to move people form one location to a different location in or out of the building.



Shelter then state the Hazard and Safety Strategy for group and self protection.
