Gil Fullen (11:53 AM): We are still seeing similar SF Costs at this time, however that will change over the next 6 months as the industry readjusts. Where we're seeing \$600/SF for new construction, Modernization light (\$200-300SF), heavy Mod (\$390-450SF), unique buildings like food services (510-610 SF), Performing Arts 750-950 sf, and STEM buildings approx. 600-700 Sf... this is only for guidance and these SF costs will vary depending on specific project considerations. Hope this helps...
