Local Non-Profits to Open Free Dental Clinic in June



PITTSBURG, CA – May 12, 2021 – The Dentist on Wheels Pittsburg Free Dental Clinic at St. Vincent de Paul is scheduled to open this June – offering free dental care for Contra Costa residents without dental insurance. A collaboration between Dentists on Wheels (DOW) and St. Vincent de Paul of Contra Costa County (SVdP), the free dental clinic aims to address the problem of dental pain and suffering experienced by residents in Contra Costa County who have no dental insurance. The 3-chair free dental clinic will soon be ready to start treating patients and helping people in need in the county to resolve their dental pain. All the dental equipment and furnishings have been donated to the free clinic. Shab Farzaneh, founder of Dentists on Wheels saw a community need and was moved to provide a solution.

The clinic, staffed by volunteer dentists, will be able to treat most patients' needs, from screenings, cleanings and check-ups to fillings, crowns, extractions and dentures.

For many patients, there is a direct link between poverty and a lack of dental insurance, and receiving dental care would normally be out of reach for low-income residents. Tooth pain and other dental issues can cause a massive drop in quality of life for those suffering. A broadening problem in low-income communities is the usage of extraction to solve tooth pain, as it is an inexpensive means of addressing the pain. This can create many long-term issues that can profoundly impact the patient's quality of life. By providing free, accessible preventative care and restorative procedures, the free dental clinic will lessen the number of extractions happening in Contra Costa County and keep the county smiling.

The 3-chair clinic, a partnership between Dentists on Wheels and St. Vincent de Paul, is being built by St. Vincent de Paul of Contra Costa County and is located at the SVdP Family Resource Center, 2210 Gladstone Dr., Pittsburg, CA 94565. The clinic is also sponsored by The California Wellness Foundation, John Muir Health, Refera, Catholic Management Services & Funeral Services, The Ranzetta Family Charitable Fund, Robert Anderson Dental Corporation, The Wilcox Family Foundation, Fremont Bank, Digital DOC, Optum, Q-Optics, Shoreview Dental, The Patterson Foundation, Dr. Amanda Backstrom, NSK Dental Instruments, XDR Radiology, as well as many dental specialists and private donors throughout Contra Costa County.

St. Vincent de Paul of Contra Costa County looks to strengthen vulnerable families by providing not only free dental care, but by also providing relief from food insecurity, (free meals and free food pantries), free clothing and furniture, rental assistance, job training, and shelter for the homeless.
