Q. - *What appeals to you about becoming a lawyer?*

This exposure to the harsh realities of the world saddened me, yet it also ignited a desire for change. Initially, I aspired to single-handedly transform the system. However, I soon realized the entrenched nature of its complexities. Instead, I recognized the importance of influencing policy and advocating for systemic improvements. I saw the potential to become a catalyst for change, serving as a precedent for future advocates, lawyers, and judges. It was this realization that solidified my decision to pursue a career in law. I am driven to stand alongside other lawyers, fighting for equitable justice within our community and striving to be a part of the positive change it so desperately needs.
