### **Executive Order Overview**

As of midnight, May 1, Governor Kemp's statewide order to "Shelter in Place" had officially expired. Although restrictions have been lifted, our health experts have advised that we must remain vigilant in recommended practices to ensure citizen safety. Further, Governor Kemp did extend the order for the medically fragile and elderly to "Shelter in Place" until June 12th, 11:59 pm.

### **Georgia Opens More Testing Sites for COVID-19**

The State of Georgia has worked really hard. The state is partnering with public and private entities to ensure that testing resources are available across the state. The Georgia Department of Public Health has partnered with Augusta University and Augusta University Health System. The Georgia National Guard has helped to coordinate centralized scheduling for the 50 sites we have here in our state.

**Process:** As of now, Georgians are still required to get a referral and meet certain criteria before they receive testing. However, with the number of sites increasing daily, this requirement may change in the future.

#### WHY USE OF TELEMEDICINE APP TO PROVIDE COVID-19 SCREENING?

- This is a tool that people can use from their home that will allow a provider (physician, nurse practitioner, or physician's assistant) to interact with a concerned patient. The provider is trained to screen for COVID-19. If the result is a positive screening, then further instructions will be provided on where to present for testing.
- The value of using this tool is to keep people from presenting to an Emergency Department, Urgent Care, or Doctor's office and further spreading the virus.

#### WHO CAN USE THE APP?

- Everyone can use this app, as long as they have a smartphone or computer with video capabilities. For those

#### WHAT IS THE PATIENT EXPERIENCE LIKE?

The application is user friendly. The patient begins by creating an account, which takes a couple of minutes.



- After selecting the provider, the patient will be asked a series of questions and asked to provide medical history.
   After completing a few questions, the video visit with the provider will begin.
- The average time for the visit is currently less than ten (10) minutes. As the volume grows and availability of providers changes, this average time could increase.
- At the completion of the visit, the patient will receive a visit summary at the email provided when the account
  was created. Sick slips or additional documentation can be requested and sent via email as well.

#### WHAT IS THE PROVIDER EXPERIENCE LIKE?

- The Provider is able to review the patient's medical history prior to the patient visit starting.
- On average, it takes the provider approximately a couple of minutes prior to the patient visit and no more than
  five minutes after the patient visit to complete the visit summary.


### Absentee Ballot Request for June 9th Primary Election


Please check out the images below. It is important that I share this data with my constituents so that we all understand where we are as a state and what the data is saying.



### Reopening is Up to Customers

- · Consumers are the key
- Shift to online shopping is large (thank you for market facilitator law).
- People are scared of public transit (73%), malls (75%), restaurants (60%), vacation travel (68%), and shopping (53%).
- · Reopening only really happens when those numbers go down.







- Non-interstate cars down 35-60%.
- Non-interstate trucks were down 10-20%, now approaching normal.
- · Interstate cars down 40-50%.
- Interstate trucks were down 10%, now back to normal.
- · Toll revenue down 90%.
- Peak shelter-in-place was March 24-25 nationwide.
