
PLEASE VERIFY YOUR EMAIL IN ADP IS CORRECT

VOICE YOUR SUPPORT FOR DISABILITY SERVICES IN ILLINOIS

All staff should have received an email providing the opportunity to influence a critical piece of legislation. Completing [this witness slip](#) in favor of the legislation is to inform legislators of your support to fully fund disability services. Illinois ranks 47th in the country in disability services; this legislation seeks to greatly improve this ranking, by requiring Illinois to fully fund a consultant's independent rate guidance. **The legislation is up for a floor vote tomorrow, so acting today is important.** Misericordia supports this legislation because it improves services for people with disabilities, and increases wages for DSPs and other disability professionals. So make your voice heard and help shape disability services in Illinois!
