ACCESS THE 2021 W-2 TAX FORMS ONLINE IN ADP

If you have recently changed your address please notify HR no later than Monday, January 24, 2022. It is important that you also update your address in ADP (either on a laptop, desktop or tablet; please see the instructions [here](#)).

TESTING FOR COVID AFTER A POSITIVE RESULT

As a reminder, Misericordia cannot accept OTC home COVID tests results, as they do not have at least two identifying factors, such as your name and birthdate.
