### **THE LTCNA NURSING SCHOLARSHIP APPLICATION PROCESS IS OPEN!**

#### **TO BE ELIGIBLE:**

- You must be employed as an RN, LPN, or nurse aide in a long-term care facility/program in Illinois. If employed part-time, you must work at least 15 hours per week.
- You must have at least one year of experience as an RN, LPN, or Nurse Aide in a long-term care facility/program.
- You must be accepted into the clinical portion (3rd year) of a 4 year RN program; or be enrolled in an accredited RN program, or be accepted into an accredited graduate nursing program to earn an advanced nursing degree related to long-term care.
- You must submit proof of enrollment in a nursing program.
- You must show commitment to practice as an RN in a long-term care facility/program.
