MARCH 15TH BOOSTER MANDATE FOR ALL MISERICORDIA EMPLOYEES

By now all staff have been made aware of the Illinois Executive Order for long-term care facility workers (e.g., Misericordia employees) to be up-to-date with their vaccine and booster shots. Side effects from your booster dose should be reported to your supervisor right away. We encourage you to get your booster prior to March 15th at which time the executive order for the booster mandate will go into effect. **If you have already received your booster, be sure to submit a copy of your card to your supervisor!**

PROTECTED PAID LEAVE FOR COVID EXPIRES

Following an announcement published this month in Campus Connections, we will no longer be extending our protective leave policy, per OSHA Emergency Temporary Standards (ETS). OSHA's ETS ended 1/1/2022, but Misericordia extended ours until the COVID positivity rate in Chicago remained under five percent for two consecutive weeks.

PHONE CALLS REQUESTING STAFF INFORMATION

When calls come in with inquiries on employees, such as whether or not they are working, or asking to how to reach them, we **cannot** disclose any information for the safety and confidentiality of our employees. If a family member is calling regarding an emergency, they should state this clearly to the person at reception so that appropriate steps can be taken to expedite this information reaching the employee.
