

Our Guest Preacher:  
The Most Reverend Professor Maake Masango



The Most Reverend Professor Maake Masango is an emeritus Professor of Pastoral Care and Counseling at the University of Pretoria in South Africa. He is a retired Presbyterian pastor who has served several congregations, and a former moderator of the Presbyterian Church of Southern Africa. He is also a former member of the Executive Central Committee of the World Council of Churches for more than a decade. He is past president of the All Africa Conference, and former Deputy President of the South African Council of Churches, which vigorously opposed Apartheid. Prof. Masango is an original signatory of the Kairos Document (1984), a predecessor of the Belhar Confession (1986). He was a popular preacher at the Montreat Youth Conferences in the 1990s.

Prof. Masango received his B.Th. from Federal Seminary, under Archbishop Desmond Tutu, his mentor and colleague. He earned his MA in Christian Education at the Presbyterian School of Christian Education, along with M.T.S. and Th.D. from Columbia Theological Seminary, where he was a lecturer in International Affairs under Dr. Fred Bonskovsky. He did his CPE at Grady Memorial Hospital, in Atlanta.

Having advised the Truth and Reconciliation Commission of South Africa, Prof. Masango has great interests in the areas of truth and reconciliation. He has worked for reconciliation with the governments of former Yugoslavia, Hungary, Albania, Colombia, and North Korea and South Korea, among others, to bring about peaceful transformation and reconciliation. He has lectured around the world.

Prof. Masango is also Rev. Bobby Musengwa's uncle and mentor. We are excited to have him preach for us today!

**Items for Information:**

1. The plan for parity included on pages 11-13 is based on church membership statistics and the roll of minister members of the Presbytery of Tampa Bay as reported at the end of 2019.
  - a. This is consistent with how membership statistics are used in calculating per capita apportionment for the operating costs of the Presbytery (staff and overhead in support of mission, not mission giving).
  - b. For 2021, three churches will see a change in the number of ruling elder commissioners to elect; all pastors/moderators and clerks of sessions should consult the chart to confirm the number of ruling elder commissioners to elect.
2. Annual reports on reviews terms of call and roll of the presbytery follow the attached Plan for Parity.
  - a. The reports reflect information received by October 31, 2020.
  - b. Information received before December 31, 2020, will be reflected in supplemental reports if necessary.
3. The 2020 review of session minutes for 2019 was delayed by the pandemic and is now underway. A full report of the review will be made at an upcoming presbytery meeting.
4. Various Annual Notices Required by Book of Order:
  - a. The annual synod review of presbytery minutes for 2018 has been completed and the minutes were approved with one exception. That exception has been noted and corrected in the 2019 minutes.

- b. The annual synod review of presbytery minutes for 2019 has not been completed and will be reported to the presbytery when it has been completed.
- c. In compliance with G-3.0103, the Stated Clerk notes that the Presbytery of Tampa Bay addresses the concern to give full expression to the rich diversity of the church's membership and provides for full participation and access to representatives in decision-making and employment practices through its Committee on Nominations and Representation and other efforts and continues to search for ways to enhance this work.
- d. In compliance with the Book of Order, G-3.0106, the Stated Clerk attests to the presence, in the offices of the Presbytery, of a Presbytery Operations Manual, including a Sexual Misconduct Policy and Child and Youth Protection Policy.
- e. In compliance with the Rules of Discipline, D-5.0206b, the Stated Clerk hereby lists those members of the PERMANENT JUDICIAL COMMISSION whose terms have expired within the past six years and who are resident within the bounds of the Presbytery and thus available for recall to fill temporary vacancies should the need arise for meeting the quorum requirements or the presence of a full Commission:

**Notes:**

The Form of Government requires each presbytery to “adopt and communicate to the sessions a plan for determining how many ruling elders each session should elect as commissioners to presbytery, with a goal of numerical parity of ministers of the Word and Sacrament and ruling elders” (G-3.0301) when it convenes as a council of the church.

Allocation of ruling elder commissioners is based on the official membership statistics reported as of December 31, 2019. Similarly, the number of ministers of Word and Sacrament used in computing parity is taken from the roll of ministers published at the end of 2019.

At the end of 2019, the Presbytery of Tampa Bay had 189 ministers of Word and Sacrament on the roll in the three membership categories defined in G-2.0503: Engaged in a Validated Ministry (88), Member-at-large (6), and Honorably Retired (95).

The presbytery bylaws provide that, for the purposes of determining parity between ministers of Word and Sacrament and elder commissioners, Honorably Retired (HR) ministers “shall be counted based on the average of total [HR] attendance over the past two years.” Average HR attendance in 2018 and 2019 was 16. Added to the ministers engaged in validated ministry in a congregation or other setting and the members-at-large, the goal for numerical parity is 110 elder commissioners.

The proposed plan for parity at meetings of the Presbytery of Tampa Bay in 2021 described in the chart above achieves that goal by allocating up to 114 elder commissioners according to these criteria, some of which are included in the presbytery bylaws:

- A. Elder commissioners are allocated first to churches according to G-3.0301 in the current Form of Government and the formula in G-11.0101 in the 2009-2011 Book of Order (the “old” Form of Government). Each session elects at least one elder commissioner, with an additional elder commissioner allocated at 501, 1001, 1501, and 2001 (up to a limit of five elder commissioners). Following these guidelines gives us a baseline of 70 elder commissioners.  
*NOTE: Three churches reported changes in membership at the end of 2019 that changed the number of ruling elder commissioners their sessions may elect.*
- B. Two additional elder commissioners are allocated to churches employing two or more pastors, co-pastors, associate pastors or validated ministers at the end of 2019; this adds 18 more.
- C. Following the principles of unity and diversity in F-1.0403 and of participation and representation in G-3.0103, the representation of people of color is strengthened by allocating one additional elder to Church of the Reconciler, First Hispanic, Korean (Pinellas Park), Korean (Tampa), Lakeview, Maximo, Springwater, St. John, and Trinity (St. Petersburg), for a total of 9 additional elder commissioners.
- D. Ruling elders on the Coordinating Team, Presbytery staff, and Permanent Judicial Commission, along with former moderators of this presbytery, and elder commissioners to the most recent General Assembly, average about 10.
- E. Commissioned Pastors serving churches at the end of 2019 adds 2.
- F. Certified Christian Educators who are Ruling Elders reported at the end of 2019 adds 5 more.
- G. *A seventh category used in recent years to add up to 20 more elders from churches between 120 and 499 members that do not already have 2 commissioners was again not needed this year.*

1. The Board of Trustees recommends that the Presbytery authorize creation of an Operating Support Endowment Fund by adopting the following:

The Presbytery of Tampa Bay shall establish an Operating Support Endowment Fund, a Board of Trustees designated and unrestricted fund, created from the sale of property not subject to the policy on use of funds from sale of church property sold as a result of the dissolution of particular congregations.

- a. The assets contained in this Fund are intended to provide for immediate and future benefits of Presbytery of Tampa Bay operations and be supplemental to customary per capita annual contributions from congregations. Establishment of this Fund is intended to ease the per capita financial burden on congregations in challenging times, support the continuity and vitality of Presbytery operations, and assist in minimizing increases to annual per capita apportionments.
- b. Up to 5% of the three-year average of prior June 30 market values may be distributed annually from the Operating Support Endowment Fund assets to fund part of the Presbytery of Tampa Bay operating budget for a fiscal year. This spending policy will be reviewed at least annually by the Board of Trustees and Treasurer in consultation with the Board's Investment Committee and the Presbytery's Coordinating Team for appropriateness.

2. The Board of Trustees recommends that the Presbytery amend the Presbytery of Tampa Bay Investment Policy approved on November 17, 2016, as follows: [Text to be deleted is shown with a strike-through; text to be added or inserted is shown as italic.]

**Actions Taken on behalf of Presbytery**

1. The Board of Trustees authorized the following loan during the regularly scheduled meeting (9-24-2020):

No-interest capital loan of \$41,000 to First Presbyterian Church of Crystal River (dba LifeTree Church) for the purpose of replacing the air conditioner in the main sanctuary, with \$8,000 of the principal set aside in a restricted fund for loan repayment, and repayment to be made at \$512.50 per quarter for 20 years starting the quarter after the loan is disbursed.

2. The Board of Trustees approved the following action during the regularly scheduled meeting (10-22-2020):

Subject to the concurrence of the congregation of Korean Presbyterian Church of Tampa at a duly held congregational meeting, the Presbytery of Tampa Bay approves the sale of property currently held by the church at 301 Sunset Lane, Lutz, FL, 33549 to Unicorn Property Holdings II, LLC for the purchase price of \$830,000 as indicated in the contract signed on October 12, 2020. The property is described on the contract and in Hillsborough County property records as:

3. Regarding the outstanding loan balance of Trinity Presbyterian Church, St. Petersburg, the Board of Trustees approved the following action during the regularly scheduled meeting (10-22-2020):

Trinity will repay the \$44,013.44 loan balance by paying \$15,000 to the Presbytery on Trinity's receipt of CCV's grant funds, and Trinity will pay the Presbytery \$250 per month, without interest, beginning on December 15, 2020, and continuing each month thereafter until the loan balance is repaid in full in 9.67 years on July 15, 2030. To support other churches in the Presbytery, Trinity may decide to repay the loan balance more quickly if Trinity has the opportunity to do so without compromising Trinity's ministry.

**Items for Information**

1. Texas Presbytery Foundation (TPF) reported that since inception (12/15/2016), as of 09/30/2020, the total account return of 10.31% is ahead of the composite index return of 7.13% that the fund is measured against. It is noted that because this is a time-weighted measurement it adjusts for account additions and withdrawals for a true measure of return.
2. During the COVID19 pandemic, the Board of Trustees continues to support several congregations through their property needs.
3. The Board of Trustees is analyzing several outstanding church loans with the objective of sensitively ensuring proper stewardship while meeting fiduciary obligations during these trying times.

# Beth-El

*Farmworker Ministry, Inc.*



## Who is Beth-El?

In 1976 Presbyterians in the Ruskin, FL area began a worship service for the Latino/Hispanic farmworkers who traveled to Florida to pick crops. The mission continues to grow to support farmworkers and those in our community living in poverty by addressing their critical needs of food, wellness, education, and spiritual support. Beth-El is a registered 501c3 non-profit through the Presbyterian Church U.S.A. Its board of directors is comprised of members from its three covenant partners: Peace River Presbytery, the Presbytery of Tampa Bay (PCUSA) and the Missions Ministry Team of the Cumberland Presbyterian Church. Our covenant partners support Beth-El's mission programs as equal stakeholders.

## Impact of Covid-19 on Farm working Families

Migrant farm-working families on average earn between \$15,000 - \$17,000 a year. Work availability is intermittent. This year Covid-19 complicated this scenario even more deeply. Many families experienced income loss as they couldn't travel to follow crop seasons in different parts of the country.

For the ones that ventured out and returned to the South Hillsborough area, along with the families that sheltered in place, what they face is limited housing options, employment, and opportunities.

I encountered Lydia at the Mission's lobby, she was holding the hand of her 3-year-old child. She came in need of food, diapers, and other personal items. I asked her how things were going. What she related is what I call "being caught in a perfect storm". She said, "I have the chance to work the fields to prepare for the tomato season, but the day-care centers are closed, and I am afraid to send my older children to school. I do not know what to do."

During the pandemic, Beth-El has been open and available as a resource and pastoral care center. Here migrant farm working families find assistance that offers them a sense of stability and community during these difficult times. You are part of this important work!

Our brief service takes place in the early morning shade beside the building. We greet each other with a wave. We thank God for health after illness, a return to work after months of unemployment, two new church babies due in November and one in May. We give thanks for all the ways you walk with us. We share prayer requests for children and grandchildren at school and for those who are sick or have lost loved ones.

**Motions for Presbytery**

The Coordinating Team recommends that the Presbytery of Tampa Bay take the following actions (see additional details under “Items for Information” below):

- 1. Approve forming a New Worshiping Community Task Force as described in the attached proposal.**
- 2. Approve and adopt the proposed Covenant among Presbyterian Disaster Assistance (PDA), Florida Presbyterian Disaster Assistance Network (FLAPDAN), and the six presbyteries in Florida as a member presbytery of FLAPDAN.**
- 3. Adopt the budget for 2021 as presented.**
- 4. Elect Meghann Pabst as Chair of the Committee on Nominations and Representation.**

**Items for Information**

1. The rationale and background for the New Worshiping Community Task Force is contained in the attached proposal beginning on page 50 of this packet.
2. The proposed PDA/FLAPDAN/Presbytery covenant is attached following an introductory letter from Kathy Broyard, Executive Director of FLAPDAN on page 52 of this packet.
3. The proposed 2021 budget is included in the last column of the Treasurer’s regular revenue and expense report beginning on page 42 of this packet.
4. CT is responsible for nominating members of the Committee on Nominations and Representation. Meghann Pabst is currently on CNR in the class of 2021; CT will present nominations for other vacancies.

**Actions Taken by the Coordinating Team as a Commission of the Presbytery**

1. Designated the offering at the November Stated Meeting be designated to support Feeding Tampa Bay, Inc. (10/27/2020)
2. Approved terms of compensation for 2021 for Patrice Hatley, Libby Shannon, and Bill Wildhack for recommendation to the Commission on Ministry with the addition of one additional week of study leave for each, and that they be permitted to carryover any unused 2020 vacation leave for use in 2021. CT also directed Patrice to approve a similar carryover of unused time-off for Office Administrator Ann Marie Fizzano. *Note: the terms do not include any increase in total effective salary.* (10/27/2020)

3. On request from the Commission on Church Vitality, CT authorized funding a New Worshiping Community in Plant City, FL for the first two years with \$67,500 in 2021 and \$55,000 in 2022. This came to CT because the amount is above the \$35K/year that CCV is authorized to approve under the presbytery's *Policy for Use of Funds from Sale of Church Property*. (9/10/2020)
4. Approved increasing the total offering from the Presbytery of Tampa Bay to the Native American Church Property Fund from \$2095 collected at and following the August Stated Meeting to a total of \$2500. (9/10/2020)
5. Approved holding the November 12, 2020 Stated Meeting of the Presbytery via Zoom. (9/10/2020)
6. Approved honorarium for guest preacher Margaret Kibben at the August Stated Meeting of the Presbytery. (9/10/2020)
7. Approved an emergency assistance grant for one of our ministers to cover living expenses while awaiting expected income. (9/16/2020)

## Presbytery of Tampa Bay New Worshiping Community Task Force

### **Introduction:**

Across the Presbyterian Church (USA) the Spirit of the living God has renewed within the Church a commitment to form and re-form, create and re-create new worshiping communities. These communities are as diverse and creative as the Church and as wide and wondrous as the God they serve. The formation of new worshipping communities aims to be responsive to the varied and ever-changing needs of the communities around them; faithful to the call of God to make disciples; and committed to our Reformed heritage and Presbyterian polity.

The PC(USA) intentionally chose the language of New Worshiping Community in an effort to broaden the ways we have traditionally thought about church, making space for flexible and contextually appropriate communities. *For the purposes of the 1,001 movement in the Presbyterian Church (USA), the definition of a New Worshiping Community is:*

- *New*
  - *Seeking to make and form new disciples of Jesus Christ*
  - *Taking on innovative forms of church for our changing culture*
- *Worshiping*
  - *Gathered by the Spirit to meet Jesus Christ in Word and Sacrament*
  - *Sent by the Spirit to join God's mission for the transformation of the world*
- *Community*
  - *Practicing mutual care and accountability*
  - *Developing self-sustainability in leadership and finances*

To that end and in support of these communities the Presbytery of Tampa Bay (the Presbytery) gathers this body to support, nurture, challenge, and guide the New Worshiping Communities (NWCs) within its bounds as they seek to serve Jesus Christ and the world.

### **Membership:**

- 7-8 members initially appointed by the moderator for a one-year term, with members nominated by the Committee on Nominations and Representation in accordance with their procedures beginning with the second year.
- The Commission on Church Vitality will appoint, from among its membership, a chair
- Staffed by the Associate Presbyter for Emerging Ministries with appropriate consultation by the Coach and Coordinator and Stated Clerk

### **Reporting:**

- Commission on Church Vitality and Coach and Coordinator

### **Purpose:**

- Identify, nurture, and equip leaders for service in and alongside NWCs

- Offer guidance, resources, and accountability for NWCs as they grow in faith and structure
- Educate the Presbytery's pastors, congregations, and mission partners on needs and opportunities of NWCs

**Goals/Aims:**

- Pray for NWCs and their pastors and leaders
- Prayerfully seek the Holy Spirit's guidance in the establishment of NWCs in both their mission and location
- Meet regularly with leadership (pastors and community participants) to develop and assess the following:
  - Initial ministry plans
  - Year 1, 2, and 3 benchmarks focused on the 7 marks of a Vital Congregation
  - Financial sustainability
- Ensure for NWC coaching and receive regular reports from coach
- Develop partner congregations from within the Presbytery to support, nurture, and encourage each NWC
- Provide support/best practices to ensure proper payroll/insurance/legal requirements are met
- Make regular reports and updates to Commission on Church Vitality, the Presbytery, and presbytery staff
- Assist NWC in establishing a virtual presence
- Request authorization of the right administration of the sacraments, including supporting NWCs in utilizing pulpit supply lists when appropriate, through the CCV
- Provide guidance for securing grant funding through the CCV, 1001 New Worshiping Communities, and other appropriate opportunities

The Florida Presbyterian Disaster Assistance Network (FLAPDAN) and Presbyterian Disaster Assistance (PDA) have worked closely together since FLAPDAN's inception in 2004. The relationship has evolved from PDA providing financial assistance to one of mutual benefit and support.

## COVENANT AGREEMENT

### INTRODUCTION

This document describes a covenant, not a contract. This Covenant Agreement (“Covenant”) recognizes the connectional and relational nature of the church and the importance of serving the denomination, presbyteries, and their constituent churches to strengthen the entire body of Christ. A covenant is rooted in relationships and trust with specific responsibilities for each covenant partner. It is agreed each covenant partner will assume sole responsibility for its own actions and inactions. It is also agreed the creation and signing of this covenant does not hold the partners legally liable for the actions of the other. Presbyterian Disaster Assistance, **operating for corporate purposes via Presbyterian Church (U.S.A.), A Corporation** (hereinafter referred to as “PDA”), Florida Presbyterian Disaster Assistance Network, Inc. (“FLAPDAN”), and the presbyteries of the Presbyterian Church (U.S.A.) in Florida (Florida, St. Augustine, Tampa Bay, Central Florida, Peace River, Tropical Florida, hereinafter “the six presbyteries”), are distinct entities. They are independent, neither are they being controlled by the other. They are not in a legal partnership, joint venture, or similar legal relationship. PDA, FLAPDAN and the six presbyteries may be referred to in this Covenant as a “Party” and collectively as “Parties.”

### 1. PARTNERS

The partners of this agreement are PDA, FLAPDAN, and the six presbyteries.

**PDA** is the emergency disaster response and refugee program of the Presbyterian Church (U.S.A), A Corporation. It enables congregations and mission partners of the Presbyterian Church (U.S.A.) to witness to the healing love of Christ through caring for communities adversely affected by crisis and catastrophic event. PDA:

- focuses on the long-term recovery of disaster impacted communities. Provides training and disaster preparedness for presbyteries and synods
- works collaboratively with church partners and members of the ACT Alliance (Action by Churches Together) internationally, and nationally with other faith-based responders
- connects partners locally and internationally with key organizations active in the response — United Nations, NVOAD (National Voluntary Organizations Active in Disaster), World Food Program, Red Cross, FEMA and others.

**FLAPDAN** connects the ongoing need for the six presbyteries and their congregations to be better organized and prepared to respond to traumatic events within their bounds during times of disaster. FLAPDAN:

- provides a communication link between the six presbyteries, Synod of South Atlantic, and PDA
- communicates and coordinates with other disaster organizations, including community and faith-based organizations; local, state and federal government; and the private sector
- addresses common issues of preparedness, response and long-term recovery following a disaster event

- advocates for specific needs in affected presbyteries
- identifies and develops resources
- develops and recommends protocols to be used by presbyteries in times of disaster
- supports training for disaster preparedness and response for presbyteries and their member congregations.

The **six presbyteries** work together, along with their congregations, to prepare for and respond to disasters in the state of Florida. The six presbyteries:

- Develop and promote generosity, stewardship and service for the ministries of PDA and FLAPDAN
- Participate in the mission of the church in disaster preparedness and response
- Communicate regularly with partners about the needs, opportunities and challenges of disaster ministries.

## 2. PURPOSE

This Covenant provides a framework within which the partners will cooperate, communicate, coordinate, and collaborate in carrying out their respective ministries in disaster mitigation, preparedness, response and long-term recovery operations due to disasters in the State of Florida.

## 3. COMMITMENTS

PDA AGREES TO:

- Recognize FLAPDAN and the six presbyteries as co-equal covenant partners in effecting PDA's mission in Florida
- Make, at minimum, a one-to-one dollar match to FLAPDAN in the amount equal to the sum of the annual membership contributions of the six Florida presbyteries
- Provide church-wide visibility for FLAPDAN through PDA's website, "Mission Mosaic" magazine, and emergency appeals
- Promote the FLAPDAN model for consideration to other mid councils in high disaster impact areas
- Make available PDA's Associate for Disaster Response, U.S. (or designee) to serve as ex-officio voting member of the FLAPDAN board of directors
- Make available PDA's Associate for Disaster Response, U.S. (or designee) to serve as ex-officio member of a committee or group charged with recruitment, recommendation, and evaluation of FLAPDAN executive director
- Include FLAPDAN executive director in all organizational, operational, and communication decisions pertaining to FLAPDAN's partnership with PDA as detailed in the executive director's position description

FLAPDAN AGREES TO:

- Recognize PDA and the six presbyteries as co-equal covenant partners in effecting FLAPDAN's mission

- Develop robust relationships, policies and practices that inspire presbyteries to make annual membership contributions to its general operating budget
- Keep presbyteries informed and engaged in the long-term disaster recovery taking place within their bounds
- Provide state-wide visibility for PDA within its Presbyterian and external partnerships through dual-branding marketing communications and disaster-related attire, internal and external written and oral reports, and serving as state disaster liaison and incident coordinator for FLAPDAN and PDA in disasters
- Encourage congregations, presbyteries and individuals to support the One Great Hour of Sharing and promote special PDA appeals
- Provide full financial accountability and transparency to PDA and the six presbyteries via an annual budget, quarterly revenue and expense reports, and an at least bi-annual, audited end of year report / financial review
- Include PDA's Associate for Disaster Response, U.S. (or designee) to serve as an ex-officio voting member of the FLAPDAN board of directors
- Include PDA's Associate for Disaster Response, U.S. (or designee) to serve as an ex-officio member of a committee or group charged with recruitment, recommendation, and evaluation of FLAPDAN executive director
- Include PDA's Associate for Disaster Response, U.S. (or designee) in all organizational, operational, and communication decisions pertaining to FLAPDAN's partnership with PDA as detailed in FLAPDAN's executive director position description
- Be available to consult with other mid councils in high disaster impact areas in their deliberations of developing a disaster network.

#### THE SIX PRESBYTERIES AGREE TO:

- Recognize FLAPDAN and PDA as co-equal covenant partners in effecting their respective, disaster-related missions
- Encourage congregations and individuals to make special contributions to FLAPDAN
- Include FLAPDAN membership in their annual budgets
- Encourage congregations, presbyteries and individuals to support the One Great Hour of Sharing and promote special PDA appeals
- Recommend people for the FLAPDAN board who are passionate about and committed to disaster preparedness, response, recovery, and mitigation
- Create with FLAPDAN two-way quarterly reporting protocols between the presbytery and FLAPDAN
- Provide presbytery-wide visibility for PDA within congregations through effective communication such as testimonials from volunteers, short videos, pastors' commendations from the pulpit, PDA board members' experiential reports and invitations to volunteer, etc.
- Include FLAPDAN board members and/or representatives on the agenda of regular meetings of the presbyteries
- The Executive Presbyter or equivalent will attend FLAPDAN's Annual Meeting and participate in special meetings as may be requested throughout the year

#### **4. ACCOUNTABILITY AND DOCUMENTATION**

FLAPDAN will make annual financial and programmatic as well as periodic reports to the other partners as requested, using Presbyterian Disaster Assistance's format. There will be systematic acknowledgement of gratitude for gifts received. All Parties in this will be intentional in fulfilling the intent of this Covenant.

#### **5. MODIFICATION**

This Covenant may be modified upon the mutual written consent of all the Parties.

#### **6. EFFECTIVE DATE**

The terms of this Covenant will be effective from January 1, 2021 to December 31, 2022.

#### **7. REVIEW AND RENEWAL**

This Covenant will be effective beginning January 1, 2021 (renewals are based on the two-year budget cycle of the PMA) through the calendar year 2022. The Parties shall meet at least annually for consultation and to review the progress and success of the Covenant and determine how the Covenant should continue. As part of the review process, consideration shall be given to the frequency and severity of disasters in Florida, to the continued interest of volunteer work teams, and to the progress being made to mitigate future losses.

**Helpful Information for First-Time Commissioners and Guests  
Attending a Stated Meeting of the Presbytery of Tampa Bay**

**Presbytery Meeting Basics**

As a Presbyterian, you probably already know the basics of our system of government, so let me share a few tips you may not realize:

- You are a Commissioner, not a Representative
  - This means that no one, not your session, not your pastor, not your spouse, can tell you how to vote on a matter before the presbytery. That's between you and the Holy Spirit. As it says in the Foundations of Presbyterian Polity in the Book of Order, "Presbyters are not simply to reflect the will of the people, but rather to seek together to find and represent the will of Christ." (F-3.0204)
- You may not know who all these people are and what their jobs are, so here's a brief introduction:
  - Moderator
    - Ruling Elder Jonathan Owen will be the person with the gavel at the start of the meeting but should turn the gavel over to Rev. Bobby Musengwa as the incoming moderator not long after we start. The moderator is responsible to make sure the meeting runs well and is the non-staff leader of the Presbytery.
  - Vice Moderator
    - Rev. Bobby Musengwa will similarly turn over his responsibilities early in the meeting to incoming Vice Moderator, Ruling Elder Sally Speer. The vice moderator ordinarily moderates part of each Presbytery meeting and can fill in for the moderator in other duties when necessary.
  - Presbytery Coach and Coordinator
    - Ruling Elder Patrice Hatley is our Presbytery's coach and executive. She's the head of staff for the Presbytery of Tampa Bay and has a variety of responsibilities throughout the Presbytery and in service to the larger church.
  - Associate Presbyter for Emerging Ministries
    - Rev. Libby Shannon joined the staff in this new position last summer. She may make some comments at various points during the day and will be making a report after lunch.
  - Stated Clerk
    - Rev. Bill Wildhack is the Presbytery's Stated Clerk. As the Stated Clerk, he's responsible to help plan presbytery meetings, prepare the presbytery packet, and help the moderator keep the meeting running "decently and in order" as

the Presbytery's parliamentarian. He's also the primary "Zoom host" for our electronic meetings, keeping up with polling, votes, displaying motions on screen much as he would at any in-person meeting.

- Treasurer
  - Ruling Elder Terry Dennis is our elected volunteer treasurer and reports on how your giving to and through the presbytery is being handled and advises us on financial policies, practices, and budget recommendations.
- You'll hear a lot of acronyms at a Presbytery meeting. Mostly these refer to our Committees and Commissions. Some translations:
  - GA (General Assembly) and OGA (Office of the General Assembly)
    - The General Assembly is the most inclusive governing body in the church, made up of commissioners from every presbytery, and the Office of the General Assembly manages day to day affairs of the church in support of all of us.
  - COM (Commission on Ministry)
    - The Commission on Ministry is the primary body responsible for making decisions about relationships between pastors and churches, whether a particular minister may become a member of the Presbytery, etc. It does some of its work in regional groupings. We will be electing a new chair of COM at this meeting.
  - CPM (Commission on Preparation for Ministry)
    - The Commission on Preparation is the primary body responsible for those seeking to become ministers, also known as Inquirers and Candidates. At this meeting, CPM will be asking the presbytery to approve reducing the size of the commission and elect ministers and elders to serve as ordination exam readers for the year to come. Chaired by Rev. Paul Suich.
  - CCV (Commission on Church Vitality)
    - CCV's work in 2020 has largely focused on assisting congregations and ministries with financial resources in response to COVID-19, but it has also continued to work with churches and new worshiping communities to start new ministries. CCV is chaired by Rev. Andy Walton.
  - BoT (Board of Trustees)
    - The Board of Trustees is a commission of the Presbytery responsible for the civil side of Presbytery business, implementing decisions of the main body, but also approving requests from churches for things like leasing their sanctuary, selling

property, etc. Chaired by Rev. Norm Hatter, BoT has will have two policy recommendations for us to consider at the November meeting.

- CNR (Committee on Nominating and Representation)
  - CNR is responsible for nominating ministers and Ruling Elders to most committees and commissions, and for advising the presbytery regarding the implementation of principles of unity and diversity, advocating for diversity in leadership, and more in accordance with the principles of unity and diversity in the Foundations of Presbyterian Polity and the Form of Government in the Book of Order. Be sure to share your gifts and talents with Chair Rev. Mike Loudon!
- CT (Coordinating Team)
  - As the leadership group of the Presbytery, the Coordinating Team is a Commission made up of the chairs of each group above as well as the Moderator and Vice-Moderator. The outgoing Moderator acts as the chair of the CT, while the Treasurer, Stated Clerk and Presbytery Coach and Coordinator all serve as ex officio members of the Team. Jonathan Owen will automatically became chair of CT at our meeting in November as soon as Bobby Musengwa is installed as moderator.
- Presbytery meetings are guided by the most recent edition of *Robert's Rules of Order: Newly Revised* (RONR) – and that's been the **newly released 12th Edition** since September 1, 2020!
  - The Form of Government in the Book of Order directs (G-3.0105) that Presbyterian councils (such as the session, presbytery, and general assembly) are governed by RONR whenever it doesn't conflict with the Book of Order. That doesn't mean you have to be a parliamentary expert to attend meetings, but you should probably learn the basics below if you want the meeting to make sense once business begins.

#### **Robert's Rules Quick Guide**

Here's a quick summary of your rights and responsibilities under Robert's Rules. Generally, these rules are intended to reduce tension, protect the rights and voice of anyone who might find themselves in the minority on something and, of course, keep us doing things "decently and in order" (1 Cor. 14:40, ESV).

- Always address your comments to the Moderator first (not "Madam Moderator or Mr. Moderator, just "moderator"), and then to the presenter or speaker only after being recognized by the moderator and given permission to speak.

- Generally, don't interrupt another speaker, but wait until you're recognized by the Moderator, but there are some exceptions. **NOTE: When meeting on Zoom, you should raise your "Zoom hand" and also send a quick note on things like these to the meeting host in the Zoom chat rather than unmuting yourself and interrupting.**
  - You can't hear what's going on or you're so uncomfortable over the room temperature, etc. you can't stay in the meeting (say, "Point of Privilege" then explain the problem when the moderator recognizes you)
  - You think something was wrong with what just happened (say, "Point of Order" then state your objection when the moderator recognizes you. The moderator will then decide if you're right or not.)
- Some motions it may be useful to know about:
  - Move the Previous Question (a.k.a. Call the Question)
    - A request to vote on whether to vote on a pending matter. This motion requires a second but isn't debatable and can only be made after the Moderator recognizes you, so no one should ever just shout it out. Typically, it's made when someone thinks we've hit the limit of productive discussion and we're running in circles. It is NOT appropriate to use this to shut down debate prematurely.
    - When you hear "Move the Question" or "Call the Question," be aware that the next vote is *not* on whatever it is we've been talking about, but on whether to continue discussion. An affirmative vote will end discussion, and then the next vote is on the main motion.
    - To protect the rights of others to be heard, this motion requires a 2/3 majority to pass.
  - Amendments to Main Motions
    - If you want to slightly modify the language of a motion, to add, delete or replace some language, you'll want to seek recognition and say "I move to amend the motion..." when the Moderator recognizes you. This requires a second and will then be discussed and voted on. Please be ready to provide a copy of the text of your amendment to the Stated Clerk if it's more than just a couple of words. (In Zoom, you can submit this in chat.)
  - Substitute Motions
    - If you want to substantially modify a motion on the floor, changing the intent or most of the language, you need to use a Substitute Motion instead of amending the current motion. When the Moderator recognizes you, you'll say, "I move the following substitute motion" and read your alternative suggestion. You'll will need to provide a copy of the substitute motion to the Stated Clerk.

- Division of the House (*Does not apply in electronic meetings*)
  - If you think that a voice vote was too close to call, any member of the Presbytery may request a “Division of the House” or vote by raised hands or ballot.
- Order of the Day
  - Not a motion, but something you’ll see on the agenda, usually related to lunch when we meet in person. All “Order of the Day” means is that we need to drop whatever it is we’re doing when the time for that item arrives and start doing the “Order of the Day.”
- Not necessarily in Robert’s, but please follow these conventions of our Presbytery regardless:
  - **When you want to speak, please raise your “Zoom hand” and be ready to unmute yourself when the moderator calls on you.**
  - Please read the Presbytery Packet thoroughly *before* the meeting and take another look when we get to a specific item. The answers to many questions may already be in the written reports.
    - Especially, read the items on the “Consent Agenda” (if we have one) as any motions in those reports will be approved right at the beginning of the meeting unless someone requests an item to be pulled from the consent agenda for a separate discussion and vote.
    - You should also keep a copy of the Presbytery Packet handy throughout the meeting—printed or digital—since we will only show very limited portions on screen during the meeting.

#### **What makes the Presbytery of Tampa Bay different than other presbyteries?**

Several years ago our presbytery underwent a transformation process which is now being examined as we’ve lived with it for a while. This resulted in a new mission statement, some common values, and a more relational, “bottom up” model of doing its work.

Our Mission Statement—“to identify and strengthen leaders so that every congregation makes new and mature disciples for Jesus Christ”—helps us keep our focus on leadership development and outreach. Practically, this means that there is usually a component of training at Presbytery meetings, but also that there are intentional relational opportunities for us to get to know other leaders.

The core values we adopted during the transformation were to be ***relentlessly congregational, meaningfully connected, faithfully constitutional and unapologetically Christ-Centered***. We want to focus on helping our congregations succeed, our Teaching and Ruling Elders to know and lean on one another, our processes and meetings distinctively Presbyterian, while focusing not on ourselves but on our Leader, Christ.

**SPECIAL RULES OF ORDER AND STANDING RULES**  
**for Electronic Meetings of the Presbytery of Tampa Bay**

*Approved at the August 27, 2020, Stated Meeting of the Presbytery of Tampa Bay*

For the purpose of any electronic meetings of the Presbytery of Tampa Bay conducted before a regular or special meeting may be convened in person to formally adopt rules for future electronic meetings, the Presbytery approves these special rules of order and suspends any standing rules that interfere with them:

1. All business of the meeting will be conducted using Zoom and features of that platform for simultaneous visual and aural communication, seeking recognition, and vote taking.
  - a. Dialing in by phone alone without using the Zoom client for laptop/desktop computers or the Zoom app for tablets or smartphones is not permitted because of the limited tools available to interact meaningfully with the other participants in the meeting.
  - b. Additional technical guidance will be provided separately by the Coordinating Team, and the Stated Clerk will offer opportunities to practice using Zoom in advance of any online meeting of the Presbytery.
2. The presence of a quorum shall be established by sign-in to Zoom and joining the meeting. The continued presence of a quorum shall be determined by the online list of participating members.
3. While every effort will be made to provide stable access to the platform, participants are responsible for their own audio and internet connections; no action shall be invalidated on the grounds that the loss of, or poor quality of, a member's individual connection prevented participation in the meeting.
4. Greetings, reports, ceremonies, worship services, and other elements ordinarily included in meetings of the Presbytery but unrelated to items of business may be included, altered, or omitted at the discretion of the Coordinating Team.
5. To be enrolled as participants with voice and/or vote, minister members, commissioners, and corresponding members must use the free Zoom software appropriate for their device.
6. All voting participants are required to join the meeting on individual devices (one person, one device). This preserves the right of each voting member to vote individually. (If more than one device is being used in the same room, the microphone and speaker on all but one device must be muted to prevent feedback.)
7. Upon entering the meeting, all participants must ensure that the participant's name displayed by Zoom conforms to the following examples so that the moderator and stated clerk can verify the status of each participant with voice and vote or voice only:
  - Minister/Teaching Elder member: "Firstname Lastname /TE"
  - Ruling Elder Commissioner from congregations: "Firstname Lastname /REC/ Church Name"
  - Ruling Elder PTB Staff, Officer, Commission/Committee Chair: "Firstname Lastname /RE/PTB"
  - Ruling Elder member of the Permanent Judicial Commission: "Firstname Lastname /RE/PJC"

- Ruling Elder former Moderator of PTB: "Firstname Lastname /RE/FmrMod"
- Ruling Elder Commissioner to 224th GA (2020): "Firstname Lastname /RE/GA224"
- Ruling Elder Certified Christian Educator: "Firstname Lastname /RE/CCE"
- Commissioned Pastor currently serving a church: "Firstname Lastname /CP/ Church Name"
- Non-Ruling Elder Certified Christian Educator in educational ministry: "ZCE-Firstname Lastname /CCE/ Church Name"
- Corresponding Member: "ZCM- Firstname Lastname /CM/Organization"
- Guests: "ZZG- Firstname Lastname /Guest/ Church or Organization"

Use of "Z" prefixes for those with voice but not vote will help to ensure the integrity of any votes taken if any inadvertent votes are cast by any participants not authorized to vote.

8. Participants will ensure their own microphones remain muted unless recognized by the moderator to speak.
9. The "raise hand" feature on the participant list in Zoom will be used both for seeking recognition from the moderator and for voting when directed by the moderator. Participants will be recognized only using the "raise hand" feature, not by waving at the computer or device camera.
10. Zoom's "chat" feature in a meeting of the presbytery will be limited to communicating only with the Stated Clerk and electronic hosts of the Zoom meeting, like passing a note to the Stated Clerk during a meeting.
11. Any motion other than a procedural one should be entered in writing into the participant "chat" if possible before seeking recognition using the "raise hand" feature. When recognized by the moderator, participants should state that the text of the motion is in the chat, and then make the motion. No motion will be brought before the meeting from chat until after the speaker is recognized by the moderator. Submitting a motion in chat *does not* jump the line waiting to be recognized.
12. A vote taken by means of raising hands is a "division," not a "counted vote" – meaning that the moderator will quickly scroll through the list of participants for a sense of how many have voted first in favor, and then against the motion, and then rule which side has prevailed.
  - a. When the moderator seeks unanimous consent, only those who object to unanimous consent will be asked to indicate that by a raised hand (blue hand icon) or a red "x" (red x icon) on the participants list; to avoid confusion, no one who consents should take any action to indicate consent.
  - b. If the moderator is uncertain, the moderator may order a counted vote—or a member may move that a counted vote be taken (a motion for a counted vote must be seconded, is not debatable, and requires a majority vote).
  - c. At the discretion of the moderator, votes may also be done by using the green "check" (green checkmark icon) button for "yes" and the red "x" (red x icon) button for "no" on the participants screen or by using Zoom's "poll" feature.

**ADDITIONAL TECHNICAL GUIDANCE**  
**for Electronic Meetings of the Presbytery of Tampa Bay**

**BEFORE THE MEETING**

1. ***Watch for information on practice sessions in the weeks before the date of the meeting and plan to take part in one!***
2. **Use of Zoom is required.** Please download the appropriate software for your device from [https://zoom.us/download#client\\_4meeting](https://zoom.us/download#client_4meeting).
  - a. If you don't already have a free Zoom account, you may want to create one. While not strictly necessary to enable all the meeting features and aids in maintaining the integrity of the meeting, it will make using Zoom and joining the meeting easier.
  - b. After you have created a Zoom account (or if you already have one), then register for the Presbytery meeting using the link you received. *Please be sure that the email address you use when registering for the Presbytery meeting is the same email address you used to create your Zoom account.*
3. **We encourage you to join the Zoom meeting on a desktop or laptop computer** using the "[Zoom Client for Meetings](#)" available at the link above. In order to participate meaningfully, you'll need high-speed internet access, speakers or other sound output device, a microphone, and a webcam built in or attached to the computer (use of the camera is optional but strongly encouraged as participants would be visible to each other when attending meetings in person).
  - a. **If joining by computer is not possible, a tablet or smart phone may be used** with the free "Zoom Mobile App" available from Zoom at the site above or your device's app store. The same requirements for sound and video described for desktop/laptop computers also apply to tablets and smart phones.
  - b. **If your computer does not have speakers and/or a microphone** (or a place to connect a headset), or if your internet is slow, dialing in by phone for audio *while using the computer to view the video* can work. See more on how to do that at [https://support.zoom.us/hc/en-us/articles/201362663-Joining-a-meeting-by-phone#h\\_682f2e00-6a7c-4a5a-b20f-70b9b9012563](https://support.zoom.us/hc/en-us/articles/201362663-Joining-a-meeting-by-phone#h_682f2e00-6a7c-4a5a-b20f-70b9b9012563).

**ON THE DAY OF THE MEETING**

1. **Plan to sign-in to Zoom and join the Presbytery meeting at least 30-45 minutes ahead of time** to give the clerks time to verify your registration and let you in from the electronic waiting room.
2. **When you first join the meeting from the electronic waiting room,**
  - a. **Make sure that your name is displayed in Zoom according to the requirements in paragraph 7 of the Special Rules document.** If you haven't already done so in your user profile in the Zoom software before joining the meeting, you can do it after joining the meeting by clicking on the "Participants" icon at the bottom of your screen.
    - i. **On a computer**, open the **Participants** list, hover over your name on the participants list, click **More**, and choose **Rename**. You can also change your name by hovering over your

own video image, clicking on the blue box with three dots in the upper right corner of your image, and choosing **Rename**.”

- ii. **On Android or iOS devices**, open the **Participants** list and then tap your name to rename yourself.
- b. **Check to be sure that your sound and video are working.** After making sure your video and audio are working, please mute your microphones until or unless recognized by the moderator—and be ready to unmute yourself if someone calls on you!

3. **Next, if you’re using a PC or Mac**, click “Exit Full Screen,” resize the Zoom window to as big as you want it, and then click on the “Participants” and “Chat” icons.

- a. Along with showing you who else is attending, the participants window shows the “raise hand” (✋), “yes” (✅), and “no” (✗) icons at the bottom. You’ll need those to seek recognition to speak and for voting during the meeting.
- b. You’ll use chat if you need to pass a note to the Stated Clerk or electronic hosts during the meeting, or to submit the text of a motion before raising your hand to be recognized by the moderator.

4. **If you’re using an iPad, iPhone, or Android device**, click on “Participants” to access the raise hand and voting features. The chat feature may require clicking on “...” at the bottom of the screen if there’s not enough room to show all the icons. Use your device’s navigation buttons or gestures to switch back and forth.

## AFTER THE MEETING STARTS

1. **Keep your microphone muted** unless you’ve been called on to speak.
2. **Be ready to use the “raise hand” feature** if you want to speak or to use when directed to by the moderator to indicate a vote. The electronic hosts are responsible for lowering hands following votes; please *do not* lower your own hand after a vote.
  - a. When multiple participants are seeking recognition during debate on an item of business, once the moderator has called on someone all other hands raised may be lowered at the discretion of the moderator before asking if anyone else would like to speak. It is customary in debate for the moderator to seek alternating points of view.
    - i. If the moderator recognizes someone only to find they have a similar position to the last speaker, they may be asked to step aside to let another view be heard.
    - ii. If you have an “interrupting motion” (e.g. a point of order, a request for preference in recognition, etc.), you should immediately raise their hand *again* if it has been lowered by a host. If you not immediately recognized, you may unmute your microphone and say, “Moderator, I have a point of order” or “Moderator, may I be recognized for (reason)?”
3. **Voting might also be done another way** using the “yes” (✅), and “no” (✗) icons at the bottom of the participants list screen or using Zoom’s poll feature. Pay attention to the moderator for instructions if that happens.

1. You have already downloaded **ZOOM** onto your computer or device and will make sure the program is **updated**, if needed, no later than the day before the meeting.
2. You can launch **ZOOM** and, when entering, initiate both audio and video with ease.
3. You can **rename** yourself, using your first and last name, your role initials (below), and your church or ministry.
  - **/TE/(church or ministry or HR)** - Minister/Teaching Elder member
  - **/REC/Church** - Ruling Elder Commissioner from a congregation
  - **/RE/PTB** - Ruling Elder PTB Staff, Officer, Commission/Committee Chair
