### A Call to Action: Defending Democracy and Empowering Voters

Dear League Members,

Since the 2020 presidential election was held, with the largest voter turn-out in nearly a century, we are now more than ever witnessing actions to disenfranchise tens of millions of Americans from voting in future elections. There's been nothing like this since the end of Reconstruction. Southern states effectively reversed the 15th Amendment's prohibition on denying the vote based on race by enacting poll taxes, literacy tests and other restrictions that disenfranchised nearly all Black men. Decades later, with the aid of voting rights activists and faith communities working together, it took an act of Congress to prohibit such laws with the passage of the Voting Rights Act of 1965.

Today, there are attempts to dismantle the Voting Rights Act and voter suppression remains an unfortunate reality. While states temporarily expanded mail and early voting due to the coronavirus pandemic, currently there are 250 (or more) new laws proposed in 43 states to limit mail, early-in person and Election Day voting.

These actions are likely to disproportionately affect urban communities of color. Those who support this legislative action say their rationale is to eliminate the possibility for wide-spread fraud through election integrity. However, in the 2020 presidential election there was no evidence of wide-spread voter fraud that would have changed the outcome of the election.

The possibility of disenfranchising tens of millions of Americans must be met with deliberate action that **"defends democracy and empowers voters!"** This is more than a motto for the LWV. This is our **"Call to Action."** We must break down barriers by: protecting voting rights and ballot access, advocating and litigating voting rights cases, and publishing our positions on social and print media. We are against discriminatory voter ID's and for engaging in and partnering with grassroots organizations, promoting civic education in communities of color, urban and rural areas, among senior citizens, in public housing, within our sororities and social clubs, and high schools and colleges (particularly among high school seniors and first time voters). **THIS IS ACTION WE CAN DO!**

There's more we can and must do. With racial discrimination on the rise in our country and communities, let's begin by asking ourselves difficult questions and discussing serious solutions. Is there a need for equity, cultural competence and more sensitivity in our "in-reach" (within our local Leagues) and our "outreach" (in our relationships with partners and potential funders, etc.)? If so, how do we engage with each other authentically and with sensitivity? I believe we must listen to each other and not merely hear one another. It's hard work but our commitment to inclusivity and transparency will enable us to accomplish our mission, goals and objectives that will prove beneficial for everyone.

These are just a few action steps I'm proposing for your consideration as we continue working together and moving forward **"Defending Democracy and Empowering Voters."**

On March 26th, the four current members of the Legislative Reapportionment Commission (LRC), the group that will draw Pennsylvania's state house and senate voting districts this year, announced they are seeking applicants for the fifth member and chair of the commission.

This is an opportunity to appoint a chairperson who can ensure an open and consensus-driven process that considers input and mapping proposals from Pennsylvanians across the state. ## Advocacy Team Update: People Powered Fair Maps Update By Carol Kuniholm, VP of Government and Social Policy

The redistricting world has been very active and will be increasingly so in the months ahead.

**Nationally:** HR 1, the For the People Act, passed the House of Representatives. Provisions in the bill would impact Congressional redistricting in every state. LWVUS supports this bill strongly and encourages us all to contact our US senators to ask their support. You can do that online [here](#) or call and leave your own message. **Here in Pennsylvania:** LWVPA supported legislation, LACRA, the Legislative and Congressional Redistricting Act, has been introduced as House Bill 22 and Senate Bill 222. Both bills are in their respective State Government Committees.

[March toward Transparency](#), a joint advocacy effort by LWVPA and Fair Districts PA, is off to a very strong start. Over 600 volunteers have been arranging constituent meetings with legislators. As of mid-March, all senate districts and all but 18 house districts were covered, with some success in gaining co-sponsors already reported.

On March 16, legislative leaders announced appointment of four of the five members of the Legislative Reapportionment Commission. For the first time in PA history, there will be women on the commission: Senate Majority Leader Kim Ward and House Minority Leader Joanna McClinton. You can read the details [here](#). The four legislators named to the commission now have 45 days to name a fifth or that decision will go to the PA Supreme Court.

Another promising development: the [PA Redistricting website](#) has been radically updated, with maps dating back to 1906 and date dating back to 1931. The site now provides information about projected Census dates as well as all data currently available from the Census Bureau.

LWVUS has announced a national Day of Action on April 29. The date was originally meant to coincide with release of Census Data to the states. While that release is delayed until possibly late September, the Day of Action will now be an occasion to insist that maps matter. Here in PA, local Leagues and Fair Districts PA leaders are planning local and regional events to highlight some of PA's gerrymandered maps and call attention to public demand for redistricting reform and fair districts maps.

A milestone to celebrate: the Fair Districts PA volunteer speakers bureau hit the 1000 mark in early March: 1000 informational events, attended by over 42,000 Pennsylvanians, to explain redistricting, gerrymandering and the PA legislative process. Thank you to all the local Leagues who hosted events and to the League members who are among those very active speakers.

## Advocacy Team Update, Continued: Prison Gerrymandering By Carol Kuniholm, VP of Government and Social Policy

The Census Bureau continues to count people as part of the electoral districts where they are incarcerated, rather than in their home communities. This distorts representation at local and state levels, giving prison districts undeserved strength in the state legislature and reducing the influence of communities whose populations are most impacted by incarceration.

The practice defies most state constitutions and statutes, including the Pennsylvania election code (25 Pa.C.S. §1302(3)), which says:

*"[N]o individual who is confined in a penal institution shall be deemed a resident of the election district where the institution is located. The individual shall be deemed to reside where the individual was last registered before being confined in the penal institution, or if there was no registration prior to confinement, the individual shall be deemed to reside at the last known address before confinement."*

Some states have addressed the Census Bureau practice through legislation or litigation. In PA, both have been attempted, so far with no success.

LWVPA and Fair Districts PA are partnering, [Decarcerate PA](#), the [Abolitionist Law Center](#), [Straight Ahead](#), [Free the Ballot](#), [Pennsylvania Council of Churches Advocacy](#) and the [ACLU](#) of Pennsylvania in a series of six forums about gerrymandering, prison gerrymandering and the impact of both on PA prison policy.
