**DEADLINE TO SUBMIT: September 6, 2019**

**Any incomplete proposal or proposals received after the deadline will not be considered.**

The Haywood County Arts Council (HCAC) is fortunate to have a Gallery & Gifts space located at 86 N. Main Street in Waynesville, North Carolina. Throughout the year, we offer exhibits of contemporary and fine art and traditional craft. We seek to represent the variety of talented artists in the southern Appalachian mountain region. Please visit Haywood County Arts Council before submitting your proposal to get an idea of the space and how it would best suit your proposed exhibit.

Shows generally run for four weeks. While we accept exhibit proposals from non-artist members, preference will be given to local artists. **The Haywood County Arts Council exhibits multiple artists and arts organizations – not solo shows.** We encourage artists to work together to apply for cooperative shows.

- If submitting a proposal for a collaborative exhibit, all participating artists' information must be included in the proposal, along with pertinent data asked for in the application. Include high resolution (300 dpi minimum) images of artist work.
- If you are an organization submitting, we require images and pertinent information about participating artists that reflect the intention of the exhibit.

Please download the sample contract that tells the responsibilities expected from both the Arts Council and the artist(s). We hope this information helps you in your decision to apply.

Applications must include:

1. Application form
2. Resume(s)
3. Artist's statement(s)
4. Images that are representative of the work you intend to exhibit (only high resolution in jpg format will be accepted). Images may be emailed to [Artist@HaywoodArts.org](mailto:Artist@HaywoodArts.org) by the deadline (September 6, 2019),

Decisions on proposals are made by a jury and HCAC Gallery Committee. You will receive a letter in late October, 2019.
