**LBGTQ+ Clergy:**

If Settle remains in the UMC, will we be forced to accept LBGTQ+ clergy? If not now, is that anticipated in the future?

Will Settle accept a minister that does NOT agree that the Bible is the TRUTH, exception being parables?

Will Settle accept a minister who openly practices actions that are considered biblically a sin?

**LBGTQ+ Members:**

Will homosexuals be allowed to teach our Sunday School classrooms of all ages?

**Same Sex Weddings:**

Why should the congregation have any input into who gets married at Settle or anyplace else?
