Dear Plan Participant,

We're pleased to be your provider for the City of Kingsburg's 457 Plan. At MissionSquare Retirement, we're solely dedicated to helping employees like you who serve their community build retirement security. While you focus on serving others, we focus on serving you and helping you achieve your financial goals before, during, and in retirement. In this letter, you'll find key information about transitioning to your new plan and setting up your MissionSquare account.

Account Transition Dates. The transition of your account from your current provider to MissionSquare is scheduled for June 26, 2024. As part of this process, you'll be unable to make changes to your account beginning June 17, 2024, at 4pm EST through on or around July 2, 2024. Once the transition is complete, we'll notify you, and you'll be able to manage your account easily online or by contacting us.

*MissionSquare allows up to five business days to complete the transition period in our system. The transition period is typically lifted within one to two business days of receipt of funds and records in good order from the prior plan administrator. The ability of MissionSquare to complete the transition as detailed is dependent upon the delivery of reconciled funds and records in a timely manner by the prior plan administrator.

Investment Transfers. Your savings at Empower will be transferred automatically into similar funds at MissionSquare. After the transition period is complete, you'll be able to make any changes to your investments. See **Investment Transfers** in this letter for more information.

Frequently Asked Questions

What happens to my installment payments?

Installment payments will continue to be paid on your selected frequency when your account transitions to MissionSquare. Payments during June 2024 will be paid by your previous provider.

Are there any fees associated with this change?

No. You will not be charged any fees for the transition to MissionSquare. Good news! As a result of this transition, you will see reduced overall investment expenses, which means more money working for you as you save for your financial future.

Will all my account information transfer at transition?

Your beneficiary and deferral information will be sent to MissionSquare.

What transactions will be restricted during the transition period?

Your payroll deductions will continue to be contributed into the plan during the transition period. You will not be able to request fund-to-fund transfers, in-service withdrawals, benefit distributions, or beneficiary updates until the transition is complete.
