As of June 17, 2020, at 8:30 PM, the total of laboratory-confirmed and probable COVID-19 cases reported among Connecticut residents is 45,440; including 43,493 laboratory-confirmed and 1,947 probable cases. 176 patients are currently hospitalized with laboratory-confirmed COVID-19. There have been 4226 COVID-19-associated deaths. Please note that 81 new cases were reported in the past 24-hours; 70 previously reported cases were removed from the total counts due to correction of data errors.

## **Issued by Governor Lamont**

June 17, 2020: [Executive Order No. 7AAA](#)

- Technical correction to Executive Order No. 7ZZ, Section 8
- Authority to modify limitation on group sizes in child care
- Waiver of requirement to hold annual agricultural fair and reporting requirement to maintain agricultural society property tax exemption
- Mandatory COVID-19 testing for staff of private and municipal nursing home facilities, many residential communities, and assisted living services agencies

June 16, 2020: [Executive Order No. 7ZZ](#)

- Modifications to adapt to Phase 2 reopening efforts
- Restrictions on large gatherings and events

## National headlines:

- Florida, Alabama, Arizona, California, Nevada, North Carolina, Oklahoma, Oregon, South Carolina and Texas -- that are seeing record-high seven-day averages of new coronavirus cases per day, according to an analysis of data from Johns Hopkins University.
- Globally, the virus is expanding. Two of the highest daily tallies in new global cases were reported this week.
- Florida reported 3,207 additional coronavirus cases on Thursday -- the largest single-day count in the state since the pandemic, according to the state health department. Florida's total reported cases climbed to nearly 86,000, according to data (most new cases have been in Palm Beach, Broward, Miami-Dade and Monroe counties).

- More than three quarters of Florida's adult intensive care unit beds are occupied, according to data from the Florida Agency for Health Care Administration. General hospital beds were at nearly 75% capacity across the state.
- California, seeing record increases in cases, orders people to wear masks in many settings.
- Antibodies may last only two months, especially in people who didn't show symptoms, a new study finds.
